VACANT AND OVERGROWN PROPERTIES

Ivan Groom, Neighborhood Services Department, reviewed a map identifying vacant and/or overgrown properties. A non-profit organization offered to assist homeowners with cleaning up or boarding up their property. Code Enforcement has addresses of approximately 20 properties that are in violation.

Discussion: Code Enforcement procedures; request Code Enforcement to be more proactive; etc.

Cheri Coryea, Neighborhood Services Director, stated the South County Community Redevelopment Area (CRA) has a dedicated Code Enforcement Officer funded through the Community Development Block Grant (CDBG).

Remonia Lewis, resident, requested that mowing overgrown properties be given top priority specifically on 17th Street East, between the 5700 and 5800 block.

Discussion: Rights-of-way cut by road gang; property owners responsible for costs; lien placed against property; five vendors cutting grass, it takes approximately 21 days to process a request to have grass cut; etc.

OCTOBER 16, 2012

Robin DiSabatino, CRA Chairman, stated the County is researching www.VacantRegistry.com as a resource for handling vacant properties. The company will process the paperwork necessary to have grass cut, board up properties, etc., for a fee of \$200 per property and will send the County a check for \$100 per property.

NUISANCE ABATEMENT

Lieutenant William Evers, Manatee Sherriff's Office (MSO), reported that crime in the South County CRA is down 10 percent for the year.

Sergeant Eric Isola, MSO, reviewed activity on the 5700 block of 11th Street East.

Discussion: Status of Nuisance Abatement program; guidelines set forth in Ordinance 10-57; drugs and prostitution; amend current ordinance to modify number of incidents to two within a one-year period; suggested language for legislation; etc.

Michael Gallen, CRA Vice-Chairman, suggested reviewing *Florida Statute 796.07* to see if it can be made more rigid.

CENTRAL ECONOMIC DEVELOPMENT CENTER

Alison Hewitt, Central Economic Development Center (CEDC), distributed a list of services the CEDC provides to area businesses including assisting business owners with their website statistics. Information obtained from the Healthy Business Checkup form is used to evaluate the needs of the businesses.

April Childers, CEDC, stated there are more private investors than angel investors, and they are more project based.

Karen Stewart, Neighborhood Services Department, stated a proposed agreement with the CEDC will be presented to the Board of County Commissioners in October.

COMMUNITY CENTER

Ms. Coryea stated there were two responses to the Request for Proposal (RFP); one being the YMCA, which provided a complete proposal, and the second from a company, which only indicated their interest in the project. The Purchasing Department is reviewing the elements submitted compared to what was requested. The YMCA included a Charter High School in its proposal which was not part of the RFP.

Discussion: Charter School is a different use from the original intent; will the YMCA walk away if school is not approved; space constraints; school would take away from the Community Center; lack of support for approving the school; use property as a park if necessary; compatible partnership; need a facility where people/groups can meet; percentage of site allocated to the school vs. Community Center; facility available during non-school hours; etc.
