MANATEE COUNTY FEDERATION OF COMMUNITY ASSOCIATIONS RECOMMENDATIONS FOR PRIORITIES FOR ROAD IMPROVEMENTS

The Manatee County Federation of Community Associations submitted a list of recommendations for road priorities in WHITFIELD ESTATES-BALLENTINE MANOR, PALMA SOLA PARK and CEDAR HAMMOCK AREA, it being noted by the Federation that it is far better to use good 60 MPH dirt roads, such as County Line Road, than to hard surface a road, such as Saunders east of 301, and not maintain it, with recommendation that funds be budgeted for roads on a county-wide basis as opposed to allocation by districts; that such expenditures be made on basis of need, with priority to placing existing hardsurfaced roads in satisfactory condition.

In discussing the recommendations, the Board members emphacized that the roads in Manatee County are built and improvements made on basis of need after careful engineering study and consideration by the Commissioners, and stressed the importance of providing good roads to attract much needed industry to the county.

Mr. Bibey extended invitation to representatives of the Federation to accompany him on a tour of roads in his district (No. 1) so that it could be observed that other roads need paving and improving than those mentioned in the recommendations. (Mr. M. A. Hatch, who was acting for Mr. C. A. Weygant, president of M.C.F. of C.A., during his absence while on vacation, accepted the invitation.)

Mr. Bibey read a letter from the postmaster of Bowling Green regarding the condition of a road three miles west of Duette, a mail route serving twenty-seven families.

ALLEN, DR. FREDERICK
GIVEN PERMISSION TO SERVE AS MEDICAL REPRESENTATIVE 4 H CLUB CAMP

Dr. Frederick Allen, Director of the Manatee County Health Department, introduced a group of teachers taking a course in the Educational Program associated with Public Health work, for which they would receive college credit.

He asked the Board's permission to serve as medical representative for the 4-H Club Camp (Lake Alfred, Lake Placid), for the week of July 17, 1961. Upon motion by Mr. Slaughter, seconded by Mr. Bustle, permission was granted as requested.

SMITH, HAROLD L. PERMIT GRANTED FOR CONSTRUCTION OF PIER

Mr. John Benson, county engineer, submitted application of Mr. Harold L. Smith for permit to construct a pier into Palma Sola Bay from The Prada, Palma Sola Park. The application had been approved

by Col. Glenn S. Reeves, for the Planning & Zoning Commission, and the county engineer.

The county attorney advised that the status of "The Prada" was not clear, but the commissioners could not incur difficulty by granting such permits to upland owners because if anyone challenges his right to put in the pier it will be a dispute between the applicant and the challenger.

Motion was made by Mr. Klemmer that permit to construct a pier, or dock (approximately forty feet long) into Palma Sola Bay, be granted to

TOWN & COUNTRY ESTATES

PROPOSAL : OF LYNN GILMORE TO PAVE-ONE HALF STREET REF. COUNTY ATTORNEY

Mr. John Benson, county engineer, submitted proposal of Mr. Lynn Gilmore to pay the cost of paving one-half of a street (30th Street) lying between Town and Country Estates and Windsor Park. He explained that the Windsor Park developers were not yet ready to pave that portion of the street which was their responsibility, and Mr. Bilmore did not wish to be held up on the development of the balance of his subdivision, Town and Country Estates, until they were ready to pave. Check in the amount of \$1387.50 was tendered by Mr. Gilmore to cover the cost of paving involved.

The Board postponed action on this proposal until the county attorney could investigate and make a recommendation.

ALLEN, DR. FREDERICK
APPOINTED COUNTY MEDICAL EXAMINER

Motion was seconded by Mr. Bustle and carried. *

WEST COAST INLAND NAVIGATION DISTRICT REQUESTED MILLAGE TO BE INCLUDED IN BUDGET

Mr. Bustle submitted Resolution of the West Coast Inland Navigation District requesting the Board to include in the budget for 1961-1962 an item of taxation of one-quarter (.25) mill.
