BUDGET REQUESTS

Budget requests and schedules, having been prepared in detail, were distributed to the county commissioners and members of the press by Chairman Crist. He stated that all agencies were included except two, namely, County Engineer and Public Relations, which would be presented next Wednesday morning. ✓

Mr. Bruce Cox, Deputy Clerk, explained the contents of the documents relative to amount of budget for the various departments for 1960-61, expenditures to a given date, and budget requests for the fiscal year beginning October 1, 1961, (with spaces for insertion of the approved figures at a later date.) He called attention to the fact that one-item budget (millage) requests (Anna Maria Island Erosion Prevention District and Anti-Mosquito District) were not included in that group. (Millage request of West Coast Inland Navigation District received July 3, 1961.)
