ANNA MARIA, CITY OF RE: "LOOP ROAD" TO SECONDARY SYSTEM

STATE ROAD DEPARTMENT REFERRED TO COMMITTEE

Mr. James O. Ferguson, road commissioner and authorized representative, City of Anna Maria, came before the Board to request that consideration be given to approving the addition of "Loop Road" to the Secondary Road System of the Florida State Road Department. He read a letter from Mr. John R. Phillips, chairman of the Florida State Road Department, to Mr. D. Henry Clay, Acting Mayor of the City of Anna Maria, advising that

". the State Highway System is divided into the Primary Road System and the Secondary Road System in accordance with laws enacted by the 1956 Legislature.

"The Primary System consists of such roads as are designated Federal Interstate highways; roads connecting cities having a population in excess of 10,000 inhabitants, following a continuous and reasonably direct route between such cities; U. S. numbered highways; highways that connect the county seats of adjacent counties of the state in a reasonably direct route; and municipal connecting links on such roads.

"The Secondary Road System consists of such roads selected by resolution of the county commissioners of the several counties of the state.

"Our investigation indicates that the "Loop Road" in Anna Maria is not eligible for the Primary System. It is eligible for maintenance on the Secondary System, provided the Department is requested by a resolution from the County Commissioners to place this road on the State Maintained Secondary System.

"I suggest that you contact the County Commissioners of Manatee County and present your request to them.

After discussion, this matter was referred to the committee on "Road Construction Policy", Commissioners Klemmer and Bustle and County Engineer, John Benson.

HORN, DR. S. HORN
REQUEST RE ADMISSION TO MEDICAL STAFF TABLED

MANATEE VETERANS MEMORIAL HOSPITAL

Dr. W. S. Horn, Osteopathic Physician and Surgeon, appealed to the Board to have the Board of Trustees of the Manatee Veterans Memorial Hospital reconsider his application for admission to the medical staff. His application had been denied by the Trustees, and he stated he felt that he was cutt off rather abruptly without having a chance to be heard.

Chairman Crist stated that in view of the relationship that exists between the Trustees and this Board he would ask the county attorney for an opinion in connection with such matters.

The county attorney referred to Chapter 25005, Laws of 1949, establishing the hospital: Section 7 provides for the appointment of a Board of Trustees by the Board of County Commissioners and Section 8 vests in that board of trustees the power to govern the internal administration of the hospital, and the power to supervise such internal administration is not given to the Board of County Commissioners; therefore, it was his opinion that this Board has no jurisdiction whatsoever of the affairs pertaining to the internal administration of the hospital.

Dr. Horn asked a number of questions relative to final authority in matters pertaining to the hospital, opinion by the Attorney General and requirements for membership on the medical staff (as set out in the by-laws of the Board of Trustees), which the county attorney declined to answer by giving his opinion, stating that these were questions for the courts to decide.

Chairman Crist advised Dr. Horn that the letters and other documents submitted in support of his request would be carefully studied by the commissioners and the county attorney to determine if any action would be appropriate by this Board.

A letter from Mrs. Sam Bradley was read. She expressed the hope Dr. Horn would be allowed to practice in the hospital.

Mr. Wayne Mead, Mr. C. L. Johnson and Mr. Al Grossman gave their views in favor of patients in the hospital being allowed to have physicians of their choice, other than M.D.'s if preferred.

GREATER BRADENTON CHAMBER OF COMMERCE RESOLUTION RE COMPLETION OF ROAD PROJECTS

Mr. William A. Day, chairman of the roads and bridges committee of the Board of Directors of the Greater Bradenton Chamber of Commerce, submitted a resolution urging completion of road projects in the county:

WHEREAS, through properly organized committee activity citizens of Bradenton, Manatee County and members of the Greater Bradenton Chamber of Commerce, have repeatedly expressed themselves as favorable to a better road system in Bradenton and Manatee County, and,

WHEREAS, the Board of Directors of the Greater Bradenton Chamber of Commerce have already gone on record as favoring such improvements; such being the completion of U.S. 301 from the DeSoto Bridge South and the Extension from U.S. 301 North of the DeSoto Bridge to U.S. 19 and U.S. 41,

NOW THEREFORE BE IT RESOLVED, The Board of Directors of the Greater Bradenton Chamber of Commerce does reiterate its earlier stand on these improvements and does urge the various local and State Governmental Agencies to proceed as rapidly as possible, and further, that the Public be informed at an early date plans to be followed.
