The Board of County Commissioners of Manatee County, Florida, met in REGULAR SESSION in the court house in Bradenton, Florida, Monday, August 28th, 1961 at 9:30 a.m.

The meeting was called to order by Chairman Crist.

COURT ROOM IMPROVEMENTS (AIR CONDITIONING)
RECOMMENDATIONS BY BAR ASSOCIATION

Circuit Court Judge Robert Hensley and Dewey A. Dye, Jr., attorney, came before the Board to request completion of improvements to the court room (air conditioning), and that item for this purpose be included in the budget for the coming year.

They were advised that the recommendation would be considered.

ZONING ORDINANCES (PROPOSED)
RECOMMENDATIONS BY BOARD OF REALTORS

Mr. William L. Aldredge, Jr., Chairman, Planning and Zoning Committee of the Manatee County Board of Realtors, acting as initial spokesman for a group of realtors and businessmen and businesswomen (present en masse), expressed concern over the multiplicity and red tape of the zoning ordinances and procedure of administration, which they felt was creating injustices and retarding the industrial development of the county. He compared the cumbersome, difficult to translate, 81-page typewritten proposed new ordinances with the compact printed ordinances of the City of Bradenton and mentioned that there were many overlapping classifications and repetitious references throughout the document.

Recommendations were made to

- =Redraft a simpler, more easily understood and administered zoning law
- =Secure the services of a good attorney to serve as member of the Zoning Board;
- =Give thought to limiting the membership of the Board to five, and no more than six, members and see that they are qualified men who have had some business experience;
- =The Board appoint a committee from the Board of Realtors to aid in the redrafting of the zoning ordinances.

Mr. Ed Crawford, who had been with one of the major oil companies (specializing in location of facilities), offered the benefit of his many years experience in dealing with zoning problems, if desired.

Chairman Crist commented on the proposed Manatee County Zoning Ordinance:

On November 28, 1955, the Board of County Commissioners of Manatee County adopted a countywide zoning ordinance. Since that time, there have been innumerable amendments, major and minor, to the zoning ordinance. For some time we have recognized the need to pull together into one document all of the applicable zoning regulations and to eliminate the conflict and confusion which is constantly arising. In addition to the need for assembly of the pieces into a single document, a number of cor= rections need to be made in order to clear up conflicting requirements and ambiguous language. Problems of administration have come to light as a result of the experience which we have had in administering the zoning ordinance, and these need to be corrected. Problems have occurred as a result of the absence of clear-cut standards in various places in the zoning ordinance. These standards should be included to insure proper growth and development of the county. The Planning and Zoning Commission is now in the midst of preparing a major revision to our zoning ordinance, which revision is designed to incorporate the needed adjustments mentioned above. A draft of the proposed revisions has been prepared, published, and distributed to a wide variety of citizens and organizations for their review and comment. The proposed ordinance is certainly not perfect, but is a major improvement over our existing regulations. The widespread review of the proposed ordinance which is now going on by many organizations and individuals in Manatee County will certainly result in much more improvement. Further improvements will, of course, be made as necessary.

MANATEE COUNTY BAR ASSOCIATION
RE: PROPOSED NEW COUNTY ZONING ORDINANCE

COMMITTEE

A letter from the Manatee County Bar Association advised that a special zoning committee (composed of six practicing attorneys who are experienced in zoning matters, with Jackson D. Miller III as chairman) had been formed to study the proposed new county zoning ordinance and assist in any way possible to establish a workable zoning program which will protect and insure proper development of the county.

Motion that the Chairman be authorized to appoint a committee (from the Board of Realtors) to work with the zoning ordinance committee was not seconded as it was considered unnecessary for this Board to take such action. The realtors were assured that the Planning and Zoning Commission ordinance committee would be glad to work with their committee and consider any suggestions that would simplify the ordinances.
