AUTHORIZED ATTEND MEETING STATE BOARD OF HEALTH

Dr. Frederick K. Allen, Director of the Manatee County Health Department, requested permission to attend a planning conference on a home nursing program in Jacksonville on December 11th, also, a conference at the State Board of Health in Jacksonville, December 13th, concerning the problems relating to the school building program.

Upon motion by Mr. Bustle, seconded by Mr. Klemmer, Dr. Allen was authorized to attend the conferences, December 11-13, 1961 as requested.

CHITTICK FAMILY, THE  
GOSPEL TENT PERMIT GRANTED SUBJECT TO ZONING APPROVAL

Motion was made by Mr. Klemmer that The Chittick Family, evangelists, be permitted to erect a tent between East Bradenton and Samoset, on 15th Street East, subject to approval by the Planning and Zoning Commission (zoning clearance), the Sheriff (traffic) and the County Engineer (parking facilities). Motion was seconded by Mr. Bustle and carried.

1961 TAX ROLLS CERTIFIED & APPROVED

Mr. Hiram Strickland, Tax Assessor, certified the 1961 Tax Rolls to the Board on Real Estate, Personal Property, Tangible and Intangible. A committee from the Board, composed of Commissioners Bibey, Bustle and Klemmer, proceeded to examine the assessment rolls, comparing the original and two copies thereof, as required by Section 193.29 Florida Statutes. After the examination, the committee reported finding the Assessment Rolls to be correct. Upon motion by Mr. Bibey, seconded by Mr. Bustle, said rolls were certified to and executed and the Warrant of the Tax Assessor was ordered recorded. Motion carried unanimously.
