

JUNE 11, 1963

The Board of County Commissioners of Manatee County, Florida, met in SPECIAL SESSION in the Court House in Bradenton, Florida, Tuesday, June 11th, 1963 at 3:30 P. M.

The meeting was called to order by Chairman Bibey, who stated that the purpose of the meeting was to make a decision on the problem regarding advertising signs in the sign-free zone, north of the Manatee River, on parcels where right-of-way for U. S. 41-19 had been acquired.

Mrs. W. C. Johnson, president of the Manatee River Garden Club, appealed to the Board to use its influence to preserve and enhance the beauty of Manatee County.

The County Attorney made recommendations on the solution of the problem.

Mr. Crist moved that the procedure and agreement as indicated by the County Attorney be approved and that

- =the county issue the permits for those signs which were displaced by the latest condemnation suit (right-of-way acquired by eminent domain), and that these permits expire on September 10, 1965, which is the date of the three-year limitation;
- =the sign industry involved will agree to remove said signs at the expiration of the time limit, unless for some reason the sign-free zones or zoning regulations are changed or adjusted.

Motion was seconded by Mr. Clark and carried.

BOARD OF ZONING APPEALS
QUESTION RELOCATION OF SIGNS & DECISION

Motion was made by Mr. Crist that, in view of remarks by the County Attorney, (that section of the zoning ordinance regulations regarding relocation of signs on same parcel of leased property should probably go before Appeals Board for interpretation), this question be submitted to the Board of Zoning Appeals for a decision. Motion was seconded by Mr. Klemmer and carried.

Mr. Wallace stated that the action of the Board was satisfactory to the sign companies.
