The Board of County Commissioners of Manatee County, Florida, met in REGULAR SESSION in the Court House in Bradenton, Florida, Monday; February 1st, 1965, at 9:00 A. M.

The meeting was called to order by Chairman McClure.

MINUTES APPROVED

Upon motion by Mr. Clark, seconded by Mr. Taylor, Minutes of previous meetings were approved.

REGULAR MEETING OF JANUARY 25, 1965 SPECIAL MEETING OF JANUARY 26, 1965

EQUIPMENT STORAGE SHEDS INVITATION FOR BIDS AUTHORIZED

John Benson, County Engineer, requested that the Board advertise for bids to be submitted on the construction of equipment storage sheds at the new county garage and repair shop site. Motion was made by Mr. Clark that Invitation for Bids be advertised for the construction of the sheds. Motion was seconded by Mr. Taylor. During the discussion regarding estimated cost (\$5000.00 - \$6,000.00), etc., Mr. Briggs stated that he would like to have a master plan and estimated costs submitted on anticipated buildings, paving and any other improvements in connection with the garage and equipment area. Voting "Aye" were Mr. Clark, Mr. Taylor, Mr. Hutches and Mr. McClure. Mr. Briggs voted "No". Motion carried.

PARK, BEACH AND RECREATION
ARTIFICIAL FISHING REEFS - MATCHING FUNDS AVAILABLE

Walter S. Hardin came before the Board regarding the construction of artificial fishing reefs. He read a letter from Randolph Hodges, Directof or the Florida Board of Conservation, advising that one of the counties for which matching funds had been earmarked for a recreational project had been unable to comply with the necessary requirements to receive these funds and it appeared that funds might be available to assist Manatee County in construction of a new reef or completion of that for which first allocation of state recreational funds was made.

He advised that application was being made for permit to construct a reef in the bay near Bayshore Gardens. Regarding boat ramps, he stated the Park, Beach and Recreation Commission was seeking additional ramps on State Road 64 and contemplating repairs to the ramp at Fort Hamer. Upon question by Mr. Clark as to locating a ramp on old Huyler Boulevard for the Rye Bridge area, the County Engineer was requested to make a determination as to whether the county owned sufficient right-of-way for this purpose.

BRADENTON HERALD
DESIGNATED AS NEWSPAPER TO PUBLISH DELINQUENT TAX LIST

Motion was made by Mr. Hutches that the Bradenton Herald be designated
