The meeting was called to order by Chairman McClure.

MINUTES APPROVED

REGULAR MEETING OF MARCH 29, 1965

HICKMAN, EDWIN G.

REQUEST RE SETBACK VARIANCE (BOARD OF APPEALS)

Col. Edwin G. Hickman, of 4304 Riverview Boulevard West, requested the Board to halt construction of a residence on a lot adjacent to his property until the request for variance is acted upon by the Board of Appeals, April 15, 1965. (Request for variance of eightfoot setback instead of fifteen feet setback as required by present zoning regulations for that area.)

The County Attorney explained that a permit had been issued, subject to approval (of the setback) by the Appeal Board; that it had been explained to the parties involved that if they proceeded with construction it would be at their own hazard and, under regulations governing the Appeal Board, would be creating hardships for themselves. He advised the Board that under this particular case the owner would have a just legal cause to get what he is asking even if the Appeal Board turns him down; however, the Board could take any action that it sees fit.

The Chairman stated that the Board would take this matter under advisement and render a decision at the earliest possible moment.

and asked the County Engineer for comments on this reference. Mr. Benson noted that the Highway Plan should be continued to be under study at all times, but he knew of no specific instance where urgency might be involved.

In this connection, Mr. Briggs called attention to the definite need for modification in plans for the cut-off on U.S. 301 coming south on DeSoto Bridge and requested Mr. Benson to confer with the State Road Department regarding this traffic problem. (Directional information inadequate.)

WATER SUPPLY & DISTRIBUTION PROJECT

In connection with the Manatee County Water Supply & Dist. project, The County Engineer gave a progress report on personal inspection of the plans and specifications, Daytona Beach, offices of Russell and Axon, project engineers. He said that some parts of the plans were now in the Engineering Department for examination (and would be submitted for Commissioners' information, etc.); that the plans were being worked in segments (1) Building (2) Dam Structure (3) Transmission lines, etc., and designed so that there could be a number of contracts instead of only one, and work being done concurrently under several contracts would hasten completion.

COMMUNITY ANTENNAE TELEVISION SYSTEM PUBLIC HEARING SCHEDULED

The County Attorney stated that the Board has statutory authority to grant such a franchise; that the holding of a public hearing was not necessary from a legal standpoint, but if the Board desired to hold such a hearing in the public interest, notice of two weeks or ten days would be appropriate in advertising that this application (and/or any others) would be taken under consideration at a specified time.

Upon motion by Mr. Taylor, seconded by Mr. Hutches, the Board designated April 19th, 1965 as the date on which to hold a public hearing to consider the granting of franchises for Community Antennae Television System or Systems.

ZONING

The Board proceeded to consider zoning matters, presented by Vincent Wilder, which had been postponed from previous meeting.
