CERTIFICATION OF MAXIMUM MILLAGE

The County Administrator reported that the Department of Revenue has requested the County adjust the millage rate for Fiscal Year 1982-1983 to prevent the potentiality of the millage figure established with the FY 1982-1983 budget generating revenue in excess of that actually needed to fund the budget.


