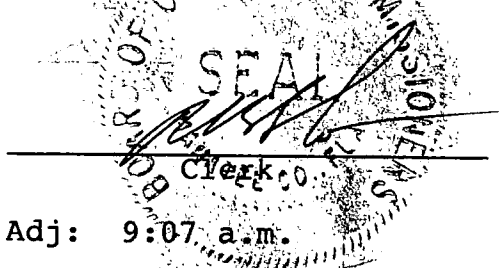
The Chairman declared the public hearing continued to July 22, 1986, 9:00 a.m. or as soon thereafter as same may be heard.
