Following discussion regarding alternative language for the next Public Hearing, motion to continue the Public Hearing to August 15, 1989, 10:00 a.m. or as soon thereafter as may be heard was withdrawn.

#### JAIL FACILITY DEVELOPMENT

The County Administrator presented goals and objectives for the development and construction of the Stockade expansion at Port Manatee and the Comprehensive 768-bed Jail Facility.

He recommended that staff be authorized to proceed with the Request for Proposal (RFP) for the Stockade and to discuss a Jail Facility site with the Port.

The shortfall is due to reduced funding from the Tourist Development Council (TDC).

Discussion: Funding from unanticipated revenues; providing projected financial plan/alternative food service plan; closing center for maintenance during slow season; legal review of Nord Corporation reverter clause; request contribution from City of Palmetto; budgeting County funds; TDC allocations.

Motion was made by Mr. Chance that \$75,000 of unanticipated revenues be used to fund the request of the Civic Center Authority. Motion was seconded by Mr. Chetlain and carried unanimously.

Jim Seuffert, Director of the Office of Management and Budget, stated that unanticipated revenues are available (i.e. sales tax).

Russell McInerney, Civic Center Authority Chairman, gave a slide presentation of the history of TDC resort tax revenues and amounts received by the Civic Center.

Recess/Reconvene. All members were present except Mr. Chance.

### SPECIAL MEDICAL CARE SHELTERS

Michael Latessa, Public Safety Director, (memo 6/9/89) advised that Florida Statute 252.355 requires voluntary registration, transportation and personnel services by the County for emergency evacuations of persons with special medical needs during a declared impending disaster. Moody School had been selected as the site.

The County is responsible for sheltering, supplies and equipment and Manatee County American Red Cross is responsible for staffing. A plan for coordination of the shelter will be prepared by Public Safety.

Motion was made by Mr. Chetlain, seconded by Mrs. Hooper and carried unanimously, to adopt
