**ORDINANCE 98-25** AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AUTHORIZING THE USE OF COUNTY NON AD VALOREM REVENUES TO MAKE UP DEBT SERVICE DEFICIENCIES OF CERTAIN OBLIGATIONS OF THE MANATEE COUNTY PORT AUTHORITY WHEN AND IF SUCH DEFICIENCIES SHOULD EVER EXIST; PROVIDING FOR A REPEALER CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

**Ernest Marshall**, Federation Manatee County Home Owners Association, inquired regarding the following concerns: adoption of Ordinance before Resolution R-98-145; what projects are being financed; maximum reserve; sales tax; ad valorem taxes; race track funds; bond anticipation notes; non ad valorem taxes, etc.

Speaking in opposition were: **Larry Patterson** and **John Patterson**, who discussed repayment of the bond and ad valorem taxes.

Discussion: Local option sales tax; indirect costs paid to County; taxes paid by Port tenants, etc.

**Ed Sheffield** and **Mark Temple**, Port Tenants Association, stated the Port tenants pay over \$500,000 in property tax.

Motion was made by Mr. McClash, and seconded by Mr. Stephens, to adopt Ordinance 98-25. Motion carried 6 to 1, with Mrs. Stein voting nay.

COMMERCIAL PAPER LOAN PROGRAM

Public (TEFRA) hearing (Notice in the Bradenton Herald 5/13/98) was held in connection with the issuance by the Manatee County Port Authority of not exceeding \$15,000,000 in aggregate principal amount of the authority's revenue note, draw No. A-1-1 as part of the Florida Local Government Finance Commission Pooled Commercial Paper Loan Program, Series B (amt issue) for the purpose of financing the costs of certain additions, extensions and improvements at Port Manatee. The proceeds of the Note will be used to finance all or a portion of the costs of: (1) Cargo Transit Warehouse and Cruise Terminal Facilities; (2) Intermodal Container Yard; (3) Berth 5 Improvement; (4) Berth 12 Improvements; (5) Berth 12 Cruise Terminal; (6) Berth 4 Creation; (7) Cold Storage Warehouse; (8) Channel Dredging; (9) Container Cranes; (10) Channel Dredging; (11) Channel Dredging; (12) Intermodal Transportation Facilities; (13) Land Acquisition; (14) Cold Storage Conversion.

Motion was made by Mr. McClash, seconded by Mr. Bruce and carried unanimously, to incorporate into this TEFRA hearing the previous comments and questions made in the Joint Board of County Commissioners and Port Authority meeting.

Mr. Marshall expressed concerns regarding: debt ratio; financial drain; giving the money back to the community; phosphate mining; odors; orimulsion; jail sales tax revenue; creating jobs in county, etc.

**R. B. Shore**, Clerk of the Circuit Court, stated the Commercial Paper Loan Program is the least expensive financing option for the County.

Discussion: Debt service ratio; Port is economically sound, etc.
