Karen Jackson-Sims, Community Affairs/Intergovernmental Relations Director, requested adoption of

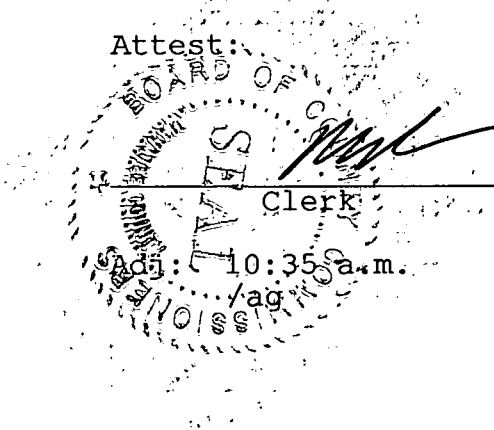
Mrs. Glass announced the death of Al Johnston, formerly with Palmetto Press.

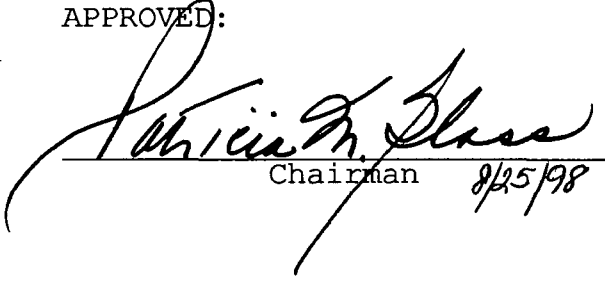
MEETING ADJOURNED
