COACH JOHN CARLOCK RECOGNITION

Chairman Van Ostenbridge gave a brief background on John Carlock's career as he proudly served his nation in uniform and served in the Manatee County School System. He dedicated his life to service of Manatee County and to the children for four decades.

CITIZEN COMMENTS (Future Agenda Items Only)

Tina Shope asked if the Board would reconsider allowing citizens to call in on public comments. She expressed concern about reinstalling the Confederate monument.

Shannon Keever expressed concern regarding reinstallation of the Confederate Monument, and proposed the Board make a statement as to what has to be done with the monument if anything. She requested the Board call for the resignation of Vanessa Baugh. It was suggested to change the times of the Board meetings or have at least one night meeting per month and reinstate the ability for the public to call in, and asked the Board sign a transparency agreement.

Jerrold Hill asked to not reinstall the Confederate monument at our Historical Courthouse or anywhere else in Manatee County.

Seneca Bristoll opposed reinstallation of the Confederate monument.

Sarah Hill stated the Confederacy stands for hate and slavery, and she is opposed to reinstalling the Confederate monument.

Sarah Parker expressed concern regarding the monument being pulled from the agenda. It is important citizens know when it will be reinstalled or not, and asked to not put monuments on public property.

Harrison Lundy, Hillsborough County, opposed reinstalling the Confederate monument as it is a symbol of hate.

Ruth Beltran addressed concern on spending time and money on things that are not needed in our community, and suggested the funds that are used for the monument be placed towards homelessness, veterans' homelessness, or funds towards the working class who are underpaid.

Jack Wallace opposed reinstalling the monument, and noted there are bigger priorities to tackle.

Karla Correa opposed reinstalling the monument.

Walter Sarkozy asked to deny a permit for 6719 3rd Street Court West, Bradenton, FL 34207, to install a side door on the house. An air conditioning unit has been permitted and installed, and electrical has been installed without permits and falsified by the homeowner. This is allowing a multi-family house on a single family residential property. He submitted photographs of the property in question.

William Clague, County Attorney, stated this is a quasi-judicial item and is not in the Board's jurisdiction, as this could be appealed to the Board at some point. The Chairman asked Mr. Sarkozy to email the information. Mr. Clague requested to refer to the appropriate staff person.

Betty Rhodes expressed concern stating the Board works for the people of Manatee County and asked the Board to stop with their own agenda. She opposed reinstalling the monument, and suggested using the \$40,000 for something else.

Kaity Danehy-Samitz questioned why there was no proclamation regarding Black History Month. She reported within the country, not one monument that was taken down has been put back up. She requested reinstating call-in comments.

Ruth Lawler addressed concerns regarding impact fees, and requested raising fees.

Joseph Molnar addressed issues regarding environmental concerns with septic systems ruining our water.

There being no further citizen comments, Chairman Van Ostenbridge closed citizen comments.

Discussion ensued regarding night meetings are difficult to hold, environmental concerns with septic system issues and are a costly problem especially in water ways, unaware of why the Confederate monument was taken off the agenda, will not vote for reinstallation, do not spend money to fix the monument, interested in getting community input on a different kind of monument, commemorating the civil rights history in Manatee County, history on the importance of knowing where that monument came from, and do not want to erase our history.

Mr. Clague reminded the audience to maintain decorum. This is a government meeting and a place where people come to speak without interruption. He asked the audience to respect the rules.

Commissioner Ballard addressed concerns regarding the pulled items and questioned restrictions for the new library on the items that can be purchased with said grant.

Tammy Parrott, Library Services Manager, explained the restrictions are for large print materials, and stated the \$100,000 coming from the Friends of the Lakewood Ranch Library has some restrictions, but only for a portion of materials regarding large print, children and Spanish language material. There are no other restrictions in the funds for the Lakewood Ranch Library, and no restrictions coming from the Library Foundation. The only restriction

Discussion ensued regarding concerns with the type of material in the books, explicit material, Board has not given direction to Ms. Parrott or Mr. Washington on these matters, there is a Library work session scheduled next month, and concern with funding materials that push a certain agenda.

Shannon Keever stated she is in support of the grants for the library, and doesn't think anyone would want to have pornography in the libraries which would be inappropriate.

Graciella Greenberg addressed banning literature in the libraries. She would like to see books in Spanish and different languages.

Janette Eubanks Kelly stated she is a retired teacher and would like to make all the literature available for everyone.

There being no further public comments, Chairman Van Ostenbridge closed public comments.

ADVERTISED PUBLIC HEARINGS (Presentation Scheduled)

50. **COUNTY ATTORNEY/ORDINANCE**

A duly advertised public hearing was held to consider adoption of proposed Ordinance 23-34, repealing the Prohibition on the retail sale of cats and dogs.

William Clague, County Attorney, introduced Ordinance 23-34, repealing Ordinance 21-28, prohibition on the retail sale of cats and dogs. On January 10, 2023, he reported on the litigation concerning Ordinance 21-28. This public hearing is to consider a legislative policy decision. The Board can continue the prohibition or repeal it, and there are strong opinions on either side of the issue.

(Enter Commissioner Kruse)

Discussion ensued regarding businesses should not be shut down, a bad precedent is being set for the State of Florida if the Ordinance is repealed, banning puppy mills is a laudable goal, unfortunately, this Ordinance doesn't achieve that goal, sends breeding underground, protect the rights of the small businesses, and this is federal issue.

Jean Shanahan, Stacy Wilkinson, Christine Noriaga, Laura Weiss and Lucy Kacela, Shannon Keever, Luther Wilkins, Holly Barber and Kate McFall urged the Board to keep the ban on the retail sale of cats and dogs.

Samir Sutaria stated his family owns Petland in Sarasota and have been in operation for two years. Petland strives to maintain the best environment with the highest standard of quality and care, and only works with licensed breeders. If there are violations with the breeders, Petland refuses to continue business with them. He urged the Board to reverse the ban on the retail sale of puppies.

Carol Whitmore noted the program has not even started yet, and the judge ruled the County was not in the wrong instituting the ban. She encouraged the Board to continue the ban on the retail sale of pets.

Neil Benecke stated he is one of the three brothers that own the Petland Bradenton store and have been owners for the last 16 years. They are family owned and operated with 50 year experience in the pet business. He requested the ban be repealed so consumers can purchase healthy pets.

Melissa Zapata, resident of Pinellas County, quoted Article 10, Section 32 of the Florida State Constitution regarding the humane treatment of animals, which is a fundamental value to the people of the State of Florida.

There being no further public comment, Chairman Van Ostenbridge closed public comment.

Motion - Adopt

A motion was made by Commissioner Rahn and seconded by Chairman Van Ostenbridge, to adopt Ordinance 23-34.

Discussion continued to do the right thing, local, state and federal levels, to protect the Constitution, having a grass roots effort to accomplish things, as more and more municipalities agree on things, actually believe in protecting animal rights, do the right thing for Manatee County, the ban is not illegal, inhumane practices are wrong, and there is no evidence PetLand is treating their animals inhumanely, and there is an enforceable tethering ordinance in Manatee County.

The motion carried 5-1, with Commissioner Kruse voting nay, and Commissioner Baugh absent.

49. PROPERTY MANAGEMENT/FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AGREEMENT

Dr. Scott L. Hopes, County Administrator, reported this is a FDOT property that has been in past discussions, and this acquisition will provide the property for Phase II for the Parrish Park located off of Fort Hamer Road.

Charlie Bishop, Deputy County Administrator, presented slides and noted this is a great benefit for the community of Parrish. Charles Meador, Property Acquisition Division Manager, and Tim Cristello, Senior Real Property Specialist, have been working with FDOT to acquire the land. Tom Yarger, Property Management, will present slides of Phase I and potentially part of Phase II.

Mr. Meador, reported 14.6 acres was acquired from FDOT, and this is a standard FDOT contract to purchase the land.

Dr. Hopes noted FDOT agreed to sell the land and direct those funds to a roundabout at the north end of Longboat Key.

Mr. Yarger gave a brief overview of what has been done for Phase I and Phase II design for the Parrish Community Park. He showed the 60 percent design for Phase I.

Mr. Bishop responded the dog park will be at Ola Mae Sims Park to make the current park larger with better enhancements, since Parrish Park and Ola Mae Sims Park are close to each other.

Mr. Yarger displayed Phase II Conceptual Design and pointed out details and referred to a slide showing what both Phase I and II look like on the combined parcel.

There being no public comment, Chairman Van Ostenbridge closed public comment.

A motion was made by Commissioner Satcher, seconded by Commissioner Kruse, and carried 6-0, with Commissioner Baugh absent to approve execution of an Agreement to Sell and Purchase with the State of Florida Department of Transportation (FDOT) for property located at 11808 and 11818 73rd Street East along the East Side of Fort Hamer Road, Parrish.

51. **COUNTY ATTORNEY/RESOLUTION**

William Clague, County Attorney, explained the Board directed him on January 10, 2023, to prepare a resolution designating Commissioner Aides be under the supervision of Commissioners rather than the County Administrator. Resolution R-23-023 follows examples researched from other jurisdictions and designates the Commissioners as supervisors, and places the Aides on the administration side under the County's personnel policy which is established by this Board. It also places authority for compensation and the number of aides under Commissioner's budgetary decision making. Hiring is facilitated by administration, but the hiring decisions are to be made by individual Commissioners.

Commissioner Kruse stated he supports the Resolution and added that some places have the head aide be in charge of the other aides.

Mr. Clague responded that the intention is to get the process started and there are details and items to be filled in once the Resolution is adopted. Procedures will be implemented to go through the Human Resources director as far as scheduling and which aides reports to which Commissioner.

Discussion ensued making sure the framework is structured, Resolution is very clear who the aides report to, practical aspects, better framework, and have the Vice-Chairman oversee the details in question.

There being no public comment, Chairman Van Ostenbridge closed public comment.

A motion was made by Commissioner Satcher, seconded by Commissioner Van Ostenbridge, and carried 6-0, with Commissioner Baugh absent, to adopt Resolution R-23-023.
