Ms. Ward stated each of the above cases has been reviewed and as of this date (4/26/17), the listed violations still remain for open and expired building permits. She read the recommended motion for disciplinary action: Pursuant to provisions of Manatee County Ordinances 14-08 and 14-33, based on the evidence presented, I move that the Construction Trades Board (CTB) adopt as findings of fact in the case summary and to find each contractor in violation by clear and convincing evidence, to forward a recommendation to the State Construction Industry Licensing Board for further action, to order that each contractor close all open building permits listed in their case summary within 14 days from the date of this hearing, to order that each contractor pay to Manatee County the cost incurred in processing each case in the amount of \$996, said amount to be paid within 14 days from the date of this hearing, to order that if each contractor fails to close all open permits or fails to pay the cost within 14 days from the day of this hearing, the permitting privileges shall be suspended until all open building permits are closed and all outstanding costs are paid, and to direct staff to prepare written orders consistent with this motion for execution by the Chairman.

#### Motion

After hearing the case presentations and having the opportunity to review the cases presented, Member Jensen moved to recommend the CTB adopt the recommended motion

staff has made. The motion was seconded by Member Tolson and carried 5-0, with Members Cheetham and Hennel absent.

Ms. Ward reported Thomas Borchert, Certified General Contractor, entered the meeting and his case was included in the recommended motion.

### **Motion - Amended**

A motion was made by Member Hicks, seconded by Member Tolson and carried 5-0, with Members Cheetham and Hennel absent, to delete Thomas Borchert, Case 201701126 (Item 9) from the recommended motion.

9. Thomas Borchert dba Five Star Renovations - License CGC1508629, Case 201701126
Deanna Ward, Permitting Supervisor, reviewed the open and expired permit.

Thomas Bouchert, Certified General Contractor, reported he has scheduled an inspection for the open permit.

Ms. Ward acknowledged speaking to Mr. Bouchert earlier in the day, and at that time he requested an inspection. Mail to Mr. Bouchert was returned undeliverable based on the address on file and with the Department of Business and Professional Regulation (DBPR).

Pursuant to the provisions of Manatee County Ordinance 14-08 and 14-33, and based on the evidence and testimony presented at the hearing, Member Tolson moved: (a) that the CTB adopt, as findings of fact, the statements contained in the case summary; (b) to find Thomas Borchert in violation of the following provisions by clear and convincing evidence: Section 2-6-75(a), Manatee County Code of Ordinances; 2-6-75(b), Manatee County Code of Ordinances; Section 2-6-37(a)(4), Manatee County Code of Ordinances; Section 2-6-37(b)(2), Manatee County Code of Ordinances; Section 489.129(1)(j), Florida Statutes; Section 489.129(1)(o), Florida Statutes: Section 110.6 of the 2014 Florida Building Code 5th Edition; and Section 110.1 of the 2014 Florida Building Code 5th Edition; (c) to forward a recommendation to the State Construction Industry Licensing Board for further action; (d) to order that Thomas Borchert close all open permits within fourteen (14) days from the date of this hearing; (e) to order that Thomas Borchert pay to Manatee County the costs incurred in processing this case in the amount of nine hundred ninety six dollars and no cents (\$996), said amount to be paid in full within fourteen (14) days from the date of this hearing; (f) to order that, if Thomas Borchert fails to close all open permits, or fails to pay the costs within fourteen (14) days from the date of this hearing, the permitting privileges of Thomas Borchert shall be suspended until all open permits are closed and all outstanding costs are paid; and (g) to direct staff to prepare a written order consistent with this motion for execution by the Chairman. The motion was seconded by Member Benincasa and carried 5-0, with Members Cheetham and Hennel absent.

13. Gary Merrill dba Professional Heating & Cooling - License CAC057946, Case 201701037

Deanna Ward, Permitting Supervisor, reviewed the open and expired permits.

Gary Merrill, Contractor, reported on the status of the permit.

Pursuant to the provisions of Manatee County Ordinance 14-08 and 14-33, and based on the evidence and testimony presented at the hearing, Member Benincasa moved: (a) that the CTB adopt, as findings of fact, the statements contained in the case summary; (b) to find Gary

Merrill in violation of the following provisions by clear and convincing evidence: Section 2-6-75(a), Manatee County Code of Ordinances; 2-6-75(b), Manatee County Code of Ordinances; Section 2-6-37(a)(4), Manatee County Code of Ordinances; Section 2-6-37(b)(2), Manatee County Code of Ordinances; Section 489.129(1)(j), Florida Statutes; Section 489.129(1)(o), Florida Statutes: Section 110.6 of the 2014 Florida Building Code 5th Edition; and Section 110.1 of the 2014 Florida Building Code 5th Edition; (c) to forward a recommendation to the State Construction Industry Licensing Board for further action; (d) to order that Gary Merrill close all open permits within fourteen (14) days from the date of this hearing; (e) to order that Gary Merrill pay to Manatee County the costs incurred in processing this case in the amount of nine hundred ninety six dollars and no cents (\$996), said amount to be paid in full within fourteen (14) days from the date of this hearing; (f) to order that, if Gary Merrill fails to close all open permits, or fails to pay the costs within fourteen (14) days from the date of this hearing, the permitting privileges of Gary Merrill shall be suspended until all open permits are closed and all outstanding costs are paid; and (g) to direct staff to prepare a written order consistent with this motion for execution by the Chairman. The motion was seconded by Member Hicks and carried 5-0, with Members Cheetham and Hennel absent. CT20170426DOC018

# 19. Jack Paris dba Jack Paris, Individual - License CCC057898, Case 20160544

Deanna Ward, Permitting Supervisor, reviewed the open and expired permits. The attorney for Mr. Paris appeared at the hearing on March 8, 2017, which was a continuance from December 14, 2016. On March 8th, the Board gave Mr. Paris 30 days until the next hearing to appear before the Board. Mr. Paris and his attorney were sent a new notice of hearing for today's hearing by certified mail. Staff received updated addresses for mailings from the attorney and as of today (4/26/17), the expired permits remain open.

Benjamin Lute, Attorney representing Mr. Paris, reported Mr. Paris intended to be present at the hearing, but his flight was delayed. Mr. Paris contends he did not open the permits or sign the agent authorization forms. A handwriting expert, Laurie Hoeltzel, has reviewed the forms and concluded the signatures on the forms do not belong to Mr. Paris (Declaration from the handwriting expert was submitted). He submitted a signed affidavit from Mr. Paris attesting that he did not authorize or sign forms. Upon question, Mr. Lute confirmed four of the forms were not signed by Mr. Paris. The issues with the fraudulent company (Jack Arthur Paris Roofing Company) are not isolated to Manatee County, and there is ongoing pending civil litigation and ongoing criminal investigations with DBPR.

Discussion took place pertaining to the conclusions from handwriting expert, qualifications for the handwriting expert, documentation showing that there is a criminal investigation and civil litigation, is Mr. Paris conducting business or pulling permits under another business name, Mr. Paris is not currently conducting business in Manatee County, Mr. Paris cannot close permits on jobs he did not do, and legal opinion from the County Attorney's office.

Geoffrey Nichols, Assistant County Attorney, noted this a quasi-judicial board, and the Board should make a determination on the facts and evidence presented.

Discussion took place about reviewing the documentation submitted by Mr. Lute, what was Mr. Paris' relationship with Jeffrey W. Rayl, Mr. Paris did not become aware of the open permits until he started receiving notices, and Mr. Paris is a roofer in Idaho.

Mr. Lute requested a continuation and commented on the slowness of the process for civil litigation cases and criminal investigations.

#### **APRIL 26, 2017**

Discussion continued about the open permits, need to formulate a motion to suspend his permitting privileges until such documentation can be brought to the County to show there was illegal activity without Mr. Paris' knowledge, and do not believe Mr. Paris signed the agent authorization forms.

Cindi Blake, Permitting Manager, questioned if the documentation from the handwriting expert was provided to the Department of State, Florida Division of Corporations, Notary Commissions and Apostille Certification. Upon question, Ms. Blake suggested the Board make a referral to the State Construction Industry Licensing Board and for the \$996 to be paid for staff's time and efforts.

Discussion ensued about Mr. Paris has been a victim of identity theft, Mr. Paris filed for an injunction against Mr. Rayl, Mr. Paris is willing to work with the County, and do not feel comfortable assigning fees if Mr. Paris is innocent.

C.J. Dupre, Building Official, stated inspections are needed in order to close the open and expired roofing permits. In the future, permitting staff will require identification for pulling permits. The legality of the signatures is a civil matter.

Deliberations ensued between the Board, staff and Mr. Lute.

Manatee County Code of Ordinances; 2-6-75(b), Manatee County Code of Ordinances; Section 2-6-37(a)(4), Manatee County Code of Ordinances; Section 2-6-37(b)(2), Manatee County Code of Ordinances; Section 489.129(1)(j), Florida Statutes; Section 489.129(1)(o), Florida Statutes; Section 110.6 of the 2010 Florida Building Code; and Section 110.1 of the 2010 Florida Building Code; (c) to forward a recommendation to the State Construction Industry Licensing Board for further action; (d) to order that Jack Paris close all open permits within fourteen (14) days from the date of this hearing; (e) to order that Jack Paris pay to Manatee County the costs incurred in processing this case in the amount of nine hundred ninety six dollars and no cents (\$996), said amount to be paid in full within fourteen (14) days from the date of this hearing; (f) to order that, if Jack Paris fails to close all open permits, or fails to pay the costs within fourteen (14) days from the date of this hearing, the permitting privileges of Jack Paris shall be suspended until all open permits are closed and all outstanding costs are paid; and (g) to direct staff to prepare a written order consistent with this motion for execution by the Chairman. The motion was seconded by Member Jensen and carried 5-0, with Members Cheetham and Hennel absent. CT20170426DOC019
