Deanna Ward, Permitting Supervisor, reviewed the open permits and proposed recommended motion.

Noe De La Cruz, contractor, explained he is unable to close the permit. The current homeowner has not responded to calls, because he is out of town (the previous homeowner paid for the work).

Discussion ensued about contacting the homeowner in order to close the permit, letters from staff went unanswered by contractor, permit 16040913 was issued in April 12, 2016 and is now closed, plans to resolve the issue (will send a certified letter), and a suggested motion.

After reviewing the case file, having heard the case presentation by staff, and being fully informed on the matter; Member Jensen moved that the CTB enter the documents presented into evidence, adopt staff's findings of fact and recommendations and find the contractor in violation by clear and convincing evidence. The motion was seconded by Member Cheetham and carried 4-0, with Members Benincasa, Edwards, and Hicks absent.

First Vice-Chairman advised Mr. De La Cruz that he has 14 days to clear up the matter, pay the fees, and supply a copy of the certified letter and mail receipt to staff. CT20170726DOC004

Travis Hill dba T. I. Hill Construction - License CGC1507489, Case 201701141

Ms. Ward reviewed the open permits. As of today, July 26, 2017, the listed violations remain for open for the expired permits, and the recommended motion for disciplinary action will be the same. Upon question, Ms. Ward confirmed Mr. Hill's license is current. She introduced Chris and Cathy Cooper who contracted with Mr. Hill to build a pool (permit 14050170) and has since abandoned the job.

Chris and Cathy Cooper, homeowners, relayed their history with Mr. Hill, and that they have pursued terminating Mr. Hill as their pool contractor. They are still working on the completion of their home and have taken over this permit. The pool permit remains in Mr. Hill's name, and they are unable to transfer this permit until he removes his name from the permit. They have hired a certified pool contractor who is willing to finish the job but cannot move forward until they are able to transfer the pool permit to their name. Due to a legal battle, they have not had any communication with Mr. Hill.

Discussion proceeded about the hiring of a licensed pool contractor (DuWet Pools), deck has been poured, there is no water in the pool, engineering for the stem wall, homeowners are unsure if the pool is in a flood zone, homeowners are working with staff in order to transfer the pool permit to their names, and staff's recommended motion.

After reviewing the case file, having heard the case presentation by staff, and being fully informed on the matter (especially by the homeowners); Member Hennel moved that the CTB enter the documents presented into evidence, adopt staff's findings of fact and recommendations and find the contractor in violation by clear and convincing evidence. motion was seconded by Member Cheetham and carried 4-0, with Members Benincasa, Edwards, and Hicks absent.

Brief discussion took place about Mr. Hill having 14 days to close the permit. CT20170726DOC006
