LEGISLATIVE UPDATE

Doug Wheeler, Florida Ports Council President, discussed the history of the Florida Ports Council (FPC), seaport systems, data, current Florida investments, and state and federal legislative advocacy issues. The Council also administers the Florida Seaport Transportation Economic Development (FSTED) Program and legislative bonding administration. Florida ports are being marketed as one entity via all media. Sixty percent of consumer goods come into the United States through the West Coast or Savannah. The goal of FPC is to capture consumer goods in Florida ports. The Panama Canal expansion will offer transshipment opportunities. The State will be infusing \$288 million into Florida ports and infrastructure. Specifically, the Port will be getting another \$20 million in 50/50 matched dollars. He suggested recruiting manufacturing companies to the International Gateway as Governor Rick Scott has placed a priority on reducing the sales tax on manufacturing and equipment.

Mr. Wheeler attended a meeting with Mr. Buqueras and the Congressional delegation last week in Washington D.C., regarding the Army Corps of Engineers. There is approximately \$7 billion in the Harbor Maintenance Trust Fund. The Water Resource Development Act (WRDA) is stuck in the earmark ban.

Discussion: State funding designations; Representative Bill Shuster to visit Manatee County; Realize America's Maritime Promise (RAMP) Act; ports dredging to 50 feet; Port of Savannah is a container port; how Florida ports are viewed; available acreage surrounding Port Manatee; port secondary asset; tax credits; etc.

U.S. CUSTOMS AND BORDER PROTECTION

Andrew Alexander, Port Manatee U.S. Customs and Border Protection Director, utilized a slide presentation to provide a history of the U.S. Customs and Border Protection (CBP) and the services. He explained the CBP inspection process for incoming ships to Port Manatee.

Discussion: International security programs; CBP ship/crew/cargo inspections; paperless shipments; scanning cargo; federal sequestration; etc.

PORT AUTHORITY LEGAL COUNSEL

Mitchell O. Palmer, Manatee County Attorney, presented the Proposal for the Provision of General Counsel Services as previously presented to the Authority on October 30, 2013.

Steven Lewis, Port Attorney, utilized a slide presentation to review Lewis, Longman and Walker's credentials and addressed lowering/capping their fees. Lewis, Longman, and Walker, P.A., do not work with the Port of Tampa.

Mr. Buqueras stated he would like to continue the Port's association with Lewis, Longman, and Walker, P.A. A draft fee proposal will be sent to an outside counsel for review and brought back to the Authority for approval.

Kevin Hennessey, Port Authority Attorney, explained an evaluation will need to be made regarding the risk to the Port in complex litigation.

Discussion: County Attorney's Office utilizes outside counsel less than 10 percent of the time; environmental permitting; cannot sue the County Attorney's Office; define complex litigation in agreement; etc.

Motion was made by Mr. Bustle and seconded by Mr. Chappie, to authorize the Port Director to develop and bring back a proposed contract for approval by this Port Authority with Lewis, Longman, and Walker, P.A., including an appropriate review as he sees fit with outside counsel.

Discussion: Lewis, Longman, and Walker, P.A. local office; previous fees; etc.

The motion carried 7 to 0.
