June 15, 1965

The regular meeting of the Manatee County Planning Commission convened at 1:30 P.M., with Vice-Chairman Wayne Bailey presiding.

Members present were: Messrs. Bailey; Chennault; Gregory; Hunt; Schneider; Townsend; Wilder; Wilkey; and Mrs. Galvin. Also present was Mr. Cox, Planning Director.

The Minutes of the meetings of May 11, May 18 and June 1, 1965, were approved as submitted.

NEW PUBLIC HEARING

#R-193 EDWARD L. GHIDONI. Application for rezoning from "R-1A" Residential to District "T-1" Mobilehome Rental, to permit a mobilehome park on property located between 75th St., W. and Palma Sola Bay, 1 1/4 miles north of Cortez Road, said legal description being: The north 268' of U.S. Lot #4 in Section 31, Twp. 34S, Rge. 17E.

Mr. Ghidoni stated that it was his intention to improve the park. He stated that the present lots would accommodate only a small trailer and that he wished to increase the size of the present park in order to make the lots large enough for the placement of larger trailers.

Mr. Gregory asked Mr. Ghidoni how many acres were in the present park. Mr. Ghidoni stated that there were five acres in the park, however, there were only approximately three acres of the land which was developed and being used at the present time.

Mr. Townsend asked Mr. Ghidoni how many acres were included in the proposed addition. Mr. Ghidoni stated that the complete area involved was approximately 14 acres.

Mr. Ghidoni explained to the members of the Commission regarding the fact that they did not anticipate an entrance and exit from 75th Street. He stated that they wanted the park to remain private and that they felt if the public had access from 75th Street that it may result in excessive traffic.

There were nine persons appearing in favor of the petition.

There were no objectors present.

Mr. Gregory moved that the public hearing be closed and that the petition be referred to the appropriate Committee for study and report. Mr. Schneider seconded the motion. Motion carried.

NOW THEREFORE BE IT RESOLVED that as we review, present, and adopt the Analysis Districts which make up the Comprehensive Plan for the entire county, such land deemed suitable shall be designated for future acquisition by the appropriate agency for public recreational use and development.
