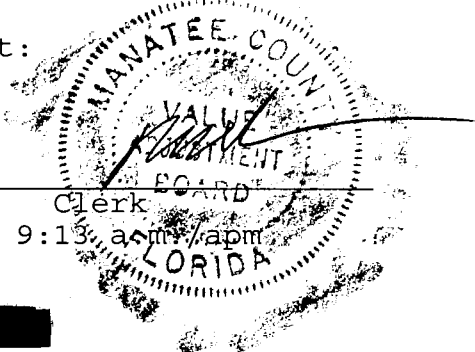
**MEETING ADJOURNED**
