Mrs. Hayes read a draft letter submitted by Ms. McVoy in response to the invoice submitted by D.P. "Rick" Wood, Special Magistrate for Real Estate Values. The Letter addressed Mr. Wood's excessive billing hours, and the notice provision in his contract.

Discussion: This has been a problem in the past with Mr. Wood; specifications of what is expected in contract; etc.

Motion was made by Mrs. von Hahmann to send a letter to Mr. Wood substantially in conformance with the draft letter, and only pay for contracted hours, and only after receiving total documentation of hours put into service, will time for addition hours be considered. The motion was seconded by Ms. Brown.

Ms. McVoy stated numerous requests by telephone and e-mail from herself and Susan Romine, Board Records Manager, have been made asking for a detailed accounting of his time. Mr. Wood has been unresponsive, and the Attorney Special Magistrate was available to Mr. Wood for any legal advise he may have needed. A history of Special Magistrate Fees was presented.

Mrs. Hayes stated she also requested total documentation from Mr. Wood.

2006 VALUE ADJUSTMENT BOARD PROCESS

Discussion: Timeliness of hearing process; time to review paperwork; assist petitioners to better fill out form; training session; last document received on the top of the petition packet; etc.

Ms. McVoy explained that the VAB process is not an opportunity to individually appraise each property, and requested that the County and the School Board support legislation to allow having only one Special Magistrate.

Motion was made by Mrs. von Hahmann, seconded by Ms. Brown and carried 5 to 0, for the County and School Board to support a recommendation to put into the Legislative program an option to not have three separate magistrates.

Discussion: Have information on the web site to assist petitioners in filling out the petition; summary of what transpired at the Special Magistrate hearings; basis needs to be clearer in the recommended order; findings of fact and conclusions of law should relate to specific documents that were presented in a more specific manner; request for reconsideration instead of appeal; etc.
