'84 AUG An 10 07 WHEREAS, Manatee County, Florida, intends to enact an Adult  $\mathfrak{F}. \ddagger$  Entertainment Ordinance and Code; and CLERK direct Court Court WHEREAS, the Adult Entertainment Ordinance and Code will MANATE GG. FLORIDA regulate adult entertainment establishments, including adult 5 dancing establishments; and 6 WHEREAS, Ordinance 79-1 indirectly controls and regulates 7 adult dancing establishments; and 8 WHEREAS, though portions of the Adult Entertainment 9 Ordinance and Code appear to cover similar subjects, some 10 conflict could arise with respect to interpretation; and 11 WHEREAS, the Adult Entertainment Ordinance and Code is com-12 prehensive and designed to supersede any prior similar or incon-13 sistent or similar ordinance. 14 NOW, THEREFORE, BE IT ORDAINED, by the Board of County 15 Commissioners of Manatee County, Florida, that: 16 Section 1. Repeal. Ordinance 79-1 adopted January 30, 1979 17 concerning the prohibition of exhibiting certain anatomical parts 18 in an establishment at which alcoholic and intoxicating beverages 19 are offered for sale and consumed on the premises is hereby 20 repealed. 21 Section 2. Effective Date.
