

1 AN ORDINANCE ADDING AMOUNTS IN EXCESS
2 OF STATUTORY SERVICE CHARGES FOR FILING
3 CIVIL ACTIONS IN CIRCUIT AND COUNTY
4 COURTS; PROVIDING FOR THE ALLOCATION OF
5 FUNDS DERIVED FROM THE ADDITIONAL CHARGES
6 FOR COUNTY FACILITIES; AND PROVIDING FOR
7 AN EFFECTIVE DATE.

8 WHEREAS, Sections 28.241, 28.2401 and 34.041, Florida Stat-
9 utes, enables the governing body of the county to impose service
10 charges in excess of those charges set by the general Laws of
11 Florida upon the institution of a civil action or proceeding.

12 WHEREAS, Sections 28.241, 28.2401 and 34.041 requires that
13 such excess shall be expended as provided by ordinance and that
14 these revenues may be allocated to provide and maintain court
15 facilities.

16 NOW, THEREFORE, BE IT ORDAINED by the Board of County Commis-
17 sioners of Manatee County, Florida, that:

18 Section 1: Effective January 15, 1985, pursuant to the
19 authority contained in Sections 28.241, 28.2401, and 34.041,
20 Florida Statutes, the Clerk of the Circuit and County Courts
21 shall add the following sums to the service charges provided
22 by those laws upon institution of any civil suit, action, or
23 proceeding and shall deposit such additional sums as collected
24 aforesaid into the General Revenue Funds of Manatee County on
25 a monthly basis.

26	Circuit Court including Probate Actions	\$15.00
27	County Court Claims	
28	Less than \$100	\$ 5.00
29	\$100 but less than \$1,000	\$10.00
30	\$1,000 but less than \$5,000	\$15.00
31	Removal of tenant action	\$15.00

32 Section 2: Such amounts as are received under this Section
33 of this ordinance which are in excess of the service charges
fixed by statute for the circuit and county courts shall be ex-
pended by the County to maintain or otherwise provide facilities
for the use of the courts of Manatee County.
