AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-05 TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON 60TH AVENUE DRIVE WEST FROM 7TH STREET COURT WEST TO 2ND STREET WEST; 36TH AVENUE EAST FROM 5TH STREET EAST TO 9TH STREET EAST; 65TH AVENUE DRIVE WEST FROM 12TH STREET WEST TO 5TH STREET WEST; 33RD STREET WEST FROM 46TH AVENUE WEST TO 49TH AVENUE DRIVE WEST; 34TH STREET WEST (CR 23) FROM CORTEZ ROAD (SR 684) TO FLORIDA BOULEVARD (CR 54); 63RD AVENUE (CR 56) FROM 14TH STREET WEST (US 41) TO 5TH STREET EAST; 59TH STREET WEST (CR 17) FROM CORTEZ ROAD (SR 684) TO MANATEE AVENUE (SR 64); COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1 be amended to add the following speed limit zones:


- ✓ 60th Avenue Drive West from 7th Street Court West to 2nd Street West 25 MPH
- ✓ 36th Avenue East from 5th Street East to 9th Street East 25 MPH
- ✓ 65th Avenue Drive West from 12th Street West to 5th Street West 25 MPH
- ✓ 33rd Street West from 46th Avenue West to 49th Avenue Drive West 25 MPH
- ✓ 34th Street West (CR 23) from Cortez Road (SR 684) to Florida Boulevard (CR 54) 40 MPH
- ✓ 63rd Avenue (CR 56) from 14th Street West (US 41) to 5th Street East 40 MPH
- ✓ 59th Street West (CR 17) from Cortez Road (SR 684) to Manatee Avenue (SR 64) 40 MPH

"S" Speed Limit

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.
