Statutes, the Board of County Commissioners of Manatee County,
Florida is empowered to regulate or prohibit the use of heavily
traveled streets by any class or kind of traffic found to be
incompatible with the normal and safe movement of traffic;

NOW, THEREFORE BE IT ORDAINED by the Board of County
Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-06, Section 1 be amended to add
the following no through truck zone:

Montgomery Avenue from 14th Street West (US 41)
to Willow Street.


Section 2. This Ordinance shall become effective
