AN ORDINANCE OF MANATEE COUNTY, FLORIDA
AMENDING MANATEE COUNTY ORDINANCE 84-04
AS AMENDED BY ORDINANCES 84-15 AND 84-24,
TO ALLOW THE STOPPING, STANDING OR PARKING
OF MOTOR VEHICLES ON 49TH STREET WEST FROM
MANATEE AVENUE (SR 64) TO 200 FEET NORTH
OF 7TH AVENUE WEST; 16TH STREET WEST FROM
53RD AVENUE WEST TO 55TH AVENUE WEST; 65TH
AVENUE DRIVE WEST FROM 5TH STREET WEST TO
12TH STREET WEST, COUNTY MAINTAINED STREETS
IN THE UNINCORPORATED AREA OF MANATEE COUNTY,
FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 316 of the Florida Statutes,
the County of Manatee, Florida, retains jurisdiction over the
public streets, highways, roadways and parking areas located
within the unincorporated areas of said County; and

NOW, THEREFORE BE IT ORDAINED by the Board of County
Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1 be amended to
remove the following no parking zones:

49th Street West from Manatee Avenue West (SR 64) to
200 feet north of 7th Avenue West (Ordinance 84-15).

16th Street West from 53rd Avenue West to 55th Avenue
West (Ordinance 84-24).

65th Avenue Drive West from 5th Street West to 12th
Street West (Ordinance 84-24).

Section 2. This Ordinance shall become effective
immediately upon receipt of the official acknowledgement from
the office of the Secretary of State in Tallahassee, Florida,
that this Ordinance has been filed with that office.
