AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-04; AS AMENDED BY ORDINANCES 84-15 AND 84-24, TO PROHIBIT THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES THROUGHOUT ALL OF SHADOW BROOK MOBILE HOME PARK ON 68TH STREET COURT EAST; 68TH STREET EAST; 67TH STREET EAST; 66TH STREET EAST; 64TH STREET EAST; 63RD STREET EAST; SHADOW BROOK LANE; 36TH AVENUE DRIVE EAST; 37TH AVENUE EAST; 38TH AVENUE EAST; 39TH AVENUE EAST; 40TH AVENUE EAST; 41ST AVENUE EAST; 43RD AVENUE EAST; AND 44TH AVENUE EAST; COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 316 of the Florida Statutes, the Board of County Commissioners of Manatee County, Florida, retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County; and

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1, be amended to add the following no parking zones:

NO PARKING AT ANY TIME:

1. 36th Avenue Drive East on the west side of the street from 63rd Street East to 68th Street Court East.
2. 68th Street Court East on the north side of the street from 36th Avenue Drive East to 46th Avenue East.

NO OVERNIGHT PARKING FROM MIDNIGHT TO 6:00 A.M.:

3. 68th Street East from 41st Avenue East to end of Shadow Brook Mobile Home Park.
4. 67th Street East from 41st Avenue East to end of Shadow Brook Mobile Home Park.
5. 66th Street East from 41st Avenue East to 43rd Avenue East.
6. 64th Street East from 41st Avenue East to 43rd Avenue East.
7. 63rd Street East from 36th Avenue Drive East to Shadow Brook Lane; and from 43rd Avenue East to end of Shadow Brook Mobile Home Park.
8. Shadow Brook Lane from 36th Avenue Drive East to 41st Avenue East.
9. 37th Avenue East from 63rd Street East to 64th Street East; and from Shadow Brook Lane to circle.
10. 38th Avenue East from 63rd Street East to 64th Street East; and from Shadow Brook Lane to circle.



11. 39th Avenue East from Shadow Brook Lane to circle.
12. 40th Avenue East from Shadow Brook Lane to circle.
13. 41st Avenue East from Shadow Brook Lane to 68th Street Court East.
14. 43rd Avenue East from 63rd Street East to 68th Street Court East.
15. 44th Avenue East from dead end to 67th Street East.

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the Office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.
