WHEREAS, pursuant to Section 316.189 (2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zones:

- Senrab Drive from Palma Sola Boulevard to Montezuma Drive 25 MPH
- San Juan Avenue from Seville Circle to 75th Street West 25 MPH
- Denarvaez Avenue from Seville Circle to 75th Street West 25 MPH
- Alhambra Drive from Palma Sola Boulevard to 75th Street West 25 MPH
- Seville Circle from Palma Sola Boulevard to Palma Sola Boulevard 25 MPH
- Montezuma Drive from Palma Sola Boulevard to Manatee Avenue 25 MPH
- Cordova Drive from Manatee Avenue to San Juan Avenue 25 MPH
- Portosueno Drive from Palma Sola Boulevard to 75th Street West 25 MPH
- Alcazar Drive from Portosueno Drive to Alhambra Drive 25 MPH
- Casabella Drive from Montezuma Drive to Estremadura Drive 25 MPH
- Estremadura Drive from San Juan Avenue to 75th Street West 25 MPH
