WHEREAS, pursuant to Section 316.008 (1)(n), Florida

Statutes, the Board of County Commissioners of Manatee County, Florida is empowered to regulate or prohibit the use of heavily traveled streets by any class or kind of traffic found to be incompatible with the normal and safe movement of traffic;

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-06, Section 1 be amended to add the following no through truck zone:

Palma Sola Boulevard from Cortez Road (SR 684) to Manatee Avenue West (SR 64).

51st Avenue West from 14th Street West (US 41) to 5th Street West.

9th Street East/Pennsylvania Avenue from Whitfield Avenue south to Nicholson Road.

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.
