AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-04; AS AMENDED BY ORDINANCES 84-15 AND 84-24, TO PROHIBIT THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 35TH STREET WEST; COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 316 of the Florida Statutes, the Board of County Commissioners of Manatee County, Florida, retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County; and

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1, be amended to add the following no parking zones:

NO PARKING FROM 8 AM TO 4 PM SCHOOL DAYS
35th Street West from 9th Avenue West
to 13th Avenue West

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the Office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.
