AN ORDINANCE OF MANATEE COUNTY, FLORIDA
AMENDING MANATEE COUNTY ORDINANCE 84-05;
TO PROHIBIT THE TRAVEL OF VEHICLES AT
SPEEDS IN EXCESS OF THE ESTABLISHED
LIMIT ON OAK RUN DRIVE; WOODLAWN CIRCLE;
WOODLAWN CIRCLE EAST; LAKE DRIVE; OAK DRIVE;
AND LEON DRIVE; COUNTY MAINTAINED STREETS
LOCATED WITHIN THE UNINCORPORATED AREA OF
MANATEE COUNTY, FLORIDA; AND PROVIDING
AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189 (2), Florida
Statutes, the Board of County Commissioners of Manatee County,
Florida may set maximum and minimum speed limit in zones after an
investigation and determination that such limits are reasonable
and in conformity with criteria promulgated by the Florida
Department of Transportation.

NOW, THEREFORE BE IT ORDAINED by the Board of County
Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add
the following speed limit zones:

| 2. Woodlawn Circle from Erie Road to
end of subdivision | 25 MPH |
| 3. Woodlawn Circle East from Woodlawn
Circle to end of subdivision | 25 MPH |
| 4. Lake Drive from Woodlawn Circle to
to end of subdivision | 25 MPH |
| 5. Oak Drive from Lake Drive to Woodlawn
Circle West | 25 MPH |
| 6. Leon Drive from Woodlawn Circle South
to Oak Drive | 25 MPH |

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the Office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.
