AN ORDINANCE OF MANATEE COUNTY,
FLORIDA, AMENDING ORDINANCE 86-13
REGULATING COMMERCIAL VENDORS AND
PEDDLERS TO PROVIDE FOR WAIVER OF
APPLICATION FEES, TO PROVIDE FOR
OMISSION OF RESTRICTIONS RELATED
TO NOISE, TO CORRECT SCRIVENER'S
ERRORS, TO PROVIDE FOR SEVERABILITY
AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
MANATEE COUNTY, FLORIDA, that Manatee County Ordinance 86-13 is
hereby amended as follows:

Section 1. Section 3. Permits, is hereby amended to
create subsection 3.05. Waiver of Application Fee,
which shall read:

"Section 3.05. Waiver of Application Fee .

The Board upon its own motion or upon
petition by an applicant for commercial vending or
peddling permit, may waive the application fee(s)
for the applicant and its agents upon a finding by
the Board that payment of the application fee(s)
would result in economic hardship to the agent(s)
of the commercial vendor or peddler.

The petition for waiver shall be in writing,
shall set forth the grounds for waiver and shall
be signed by the applicant. The applicant shall
submit the petition to the County Administrator or
his designee at the time the application for
permit is submitted."

Section 2. Section 6.01. Commercial Vending Permit,
is hereby amended to delete subsection 6.01.A.11 in its
entirety, and to renumber subsection 6.01.A.12 to
6.01.A.11.

Section 3. Section 6.02. Peddling Permit, is hereby
amended to delete subsection 6.02.A.7 in its entirety.

"V" Vendors (commercial vendors/peddler)

Section 4. Section 10. Repeal, is hereby amended to read:

"Section 10. Repeal.

Manatee County Ordinance 84-28 regulating peddlers, transient merchants and street vendors is hereby repealed in its entirety; and all other ordinances in conflict herewith are hereby repealed to the extent of such conflict. Said repeal being effective upon the effective date of this ordinance."

Section 5. Severability.

If any part, section, subsection, or other portion of this Ordinance, or any application thereof to any person or circumstance is declared to be void, unconstitutional, or invalid for any reason, such part, section, subsection, or other portion, or the prescribed application thereof, shall be severable, and the remaining provisions of this Ordinance, and all applications thereof not having been declared void, unconstitutional or invalid, shall remain in full force and effect. The Board declares that no invalid or prescribed provision or application was an inducement to the enactment of this Ordinance, and that it would have enacted this Ordinance regardless of the invalid or prescribed provision or application.


Section 6. Effective Date.

This Ordinance shall become effective upon receipt of the official acknowledgement from the office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office. Notwithstanding the receipt of the aforementioned


official acknowledgement, Ordinance 86-13 shall become effective October 1, 1986.
