AN ORDINANCE OF MANATEE COUNTY SETTING FORTH CERTAIN FINDINGS OF FACT; AUTHORIZING THE EXPENDITURE OF COUNTY FUNDS FOR THE PROVISION OF PARKING FACILITIES FOR CERTAIN EMPLOYEES, ELECTED AND APPOINTED OFFICIALS, BOARD AND COMMITTEE MEMBERS, AGENTS, SERVANTS AND INVITEES WHERE ACCESS TO PARKING WILL INCREASE EFFICIENCY IN THE PERFORMANCE OF COUNTY DUTIES; AUTHORIZING THE DEVELOPMENT OF REPORTS AND PROCEDURES NECESSARY TO IMPLEMENT THIS ORDINANCE; PROVIDING CERTAIN LIMITATIONS; AUTHORIZING THE EXPENDITURE OF PUBLIC FUNDS; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the provision of convenient and accessible parking is necessary due to frequent employment-related trips made by employees during the working hours; and

WHEREAS, the provision of adequate employee parking for certain employees is a public necessity and a prudent employer practice in keeping with the standards of the community, and making Manatee County competitive with the practice of private employers in the community; and

WHEREAS, there is a lack of parking facilities adjacent to, or within the vicinity of, many County buildings; and

WHEREAS, accessible and convenient parking enhances and promotes employee performance and efficiency; and

WHEREAS, employer-provided parking facilities have been determined to be more cost effective than other alternatives; and

WHEREAS, it is necessary to the functioning of Manatee County Government and in the best interest of Manatee County, that adequate parking be provided for employees in, or adjacent to, facilities occupied by County offices and other facilities, whether such facilities are leased or purchased by the County; and

WHEREAS, Article VIII, Section (1)(g), Florida Constitution, authorizes counties to adopt county ordinances not inconsistent with general or special law; and

WHEREAS, Section 125.01(1)(c), Florida Statutes, empowers the governing body of a County with authorization to provide and maintain County buildings; and

"P" Parking Facilities (Expenditure of Public Funds)

WHEREAS, Section 125.031, Florida Statutes, authorizes Counties to enter into leases or lease purchase arrangements related to properties needed for public purposes; and

WHEREAS, at a properly noticed public hearing, this Board of County Commissioners considered all testimony given and facts and evidence presented, and determined that the expenditure of public funds for the acquisition of parking facilities, as provided herein, will serve a predominantly public purpose.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF THE COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, that:

Section 1.

The expenditure of County funds for the acquisition, by lease, purchase, license or contract, of parking facilities as from time to time deemed necessary to serve the needs of Manatee County for the purpose of conducting business at County offices, in accordance with this Ordinance, is hereby authorized.

Section 2.

The Board of County Commissioners may authorize the development of reports, studies and procedures necessary to ascertain the parking needs of Manatee County Government and to provide for the orderly allocation and assignment of parking spaces to employees and elected and appointed officials, Board and Committee members, agents, servants and invitees who require access to parking, to enable them to travel efficiently from their principal work place to various locations throughout the County, in accordance with their duties. The County Administrator shall coordinate the work of any boards, committees or consultants appointed by the Board of County Commissioners to develop such reports, studies and procedures, and may assign staff to provide any necessary assistance.

Section 3.

This Ordinance shall not be interpreted as delegating authority to any entity or individual to enter into agreements for the purchase, lease or license of any parking space or facility, but is adopted in contemplation of the acquisition by the Board of County Commissioners, of parking facilities that may


be acquired and to provide the authority under which the Clerk of the Circuit Court of Manatee County, as Chief Financial Officer to the Board of County Commissioners, is authorized to pay the costs associated with the acquisition of parking facilities in accordance with any contract, agreement or lease, duly authorized by the Board of County Commissioners.

Section 4.


