WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zones:


- 67th Street West from Cortez Road
to 46th Avenue West 25 MPH
- 68th Street West from 45th Avenue West
to the dead end south of 46th Avenue West 25 MPH
- 45th Avenue West from 67th Street West
to 68th Street West 25 MPH
- 46th Avenue West from 67th Street West
to 68th Street West 25 MPH

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the Office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.




