AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 83-27 AND ORDINANCE 85-21 AS AMENDED BY ORDINANCE 86-29 PROVIDING FOR THE LEVY OF THE LOCAL OPTION GAS TAX AUTHORIZED UNDER SECTION 336.025, FLORIDA STATUTES; AMENDING SECTION 3 OF ORDINANCE 85-21 TO PROVIDE THAT THE LOCAL OPTION GAS TAX DISTRIBUTED TO MANATEE COUNTY MAY BE EXPENDED IN THE MANNER AUTHORIZED BY SECTION 336.025, FLORIDA STATUTES AS AMENDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Manatee County previously adopted Ordinance 83-27 levying the first four cent (4¢) local option gas tax and Ordinance 85-21 levying the five and six cent (5 and 6¢) local option gas tax; and

WHEREAS, Ordinance 83-27 and Ordinance 85-21 were amended by Ordinance 86-29; and

WHEREAS, Section 6 of Ordinance 85-21 was renumbered as Section 3 under the provisions of Ordinance 86-29; and

WHEREAS, the Board of County Commissioners has adopted Resolution R-88-27, (the "Bond Resolution") providing for the issuance of Road Improvement Bonds which will allow the pledge of local option gas tax revenues to be used to refund Special Assessment Bond Anticipation Notes and authorizes the pledge of local option gas tax revenues and the revenues received from special assessment liens imposed against certain properties for the repayment of the bonds which may be issued for the purpose of financing transportation capital projects authorized under Section 336.025, Florida Statutes; and

WHEREAS, it is necessary and in the best interest of the County to amend Ordinance 85-21 as herein provided to permit the use of portions of the five and six cent (5 and 6¢) local option gas tax revenues to be pledged to the payment of the Road Improvement Bonds in order to obtain capital for road improvement projects which may include special benefit projects requiring the paving of local or neighborhood streets and roads within Manatee County.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, that:

Section 1. Section 3 of Ordinance 85-21, as renumbered by Ordinance 86-29, is amended to read as follows:

Section 3. The proceeds of the tax distributed to Manatee County under this Ordinance shall be used for the purpose of paying the cost of capital improvements including widening, general rehabilitation, rebuilding and construction of the minor arterial and major collector streets and roads and local and neighborhood roads which are improved as Special Assessment Projects as defined in the Bond Resolution and all necessary and related costs thereto.

Section 2. This Ordinance shall take effect upon receipt of official acknowledgment from the Office of the Secretary of the State of Florida, that this Ordinance has been filed with that office.

PASSED AND DULY ADOPTED by a Majority plus one vote of the Board of County Commissioners of Manatee, Florida, this the 23rd day of February, 1988.
