AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-05; TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON ERIE ROAD (CR 10), ERIE ROAD (2ND STREET, PARRISH), ERIE ROAD (CR 75), 26TH AVENUE EAST, 12TH AVENUE NORTHWEST, AND 43RD AVENUE WEST, AND TIDEVUE ESTATES MOBILE HOME PARK; COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, and Ordinance 86-12, Section 1, be amended to add the following speed limit zones;

- Erie Road (CR 10) from US 41 (SR 45) to Ellenton-Gillette Road (SR 683) 40 MPH
- Erie Road (CR 10) from Ellenton-Gillette Road (SR 683) to Martha Road (Parrish) 40 MPH
- Erie Road (2nd Street, Parrish) from Martha Road to US 301 (SR 43) 30 MPH
- Erie Road (CR 75) from US 301 (SR 43) to the junction with East-West Erie Road (CR 10) 40 MPH
- 26th Avenue East from 33rd Street East to 45th Street East 45 MPH
- 43rd Avenue West from 24th Street West to 26th Street West 25 MPH
- 12th Avenue Northwest from 87th Street Northwest to 89th Street Northwest 20 MPH
- 10th Street Court East from 41st Avenue East to 46th Avenue Drive East 25 MPH
- 11th Street East from 41st Avenue East to 43rd Avenue Drive East 25 MPH
- 11th Street Court East from 41st Avenue East to 43rd Avenue Drive East 25 MPH
- 12th Street East from 41st Avenue East to Tidevue Boulevard 25 MPH
- 12th Street Court East from 41st Avenue East to 45th Avenue Drive East 25 MPH

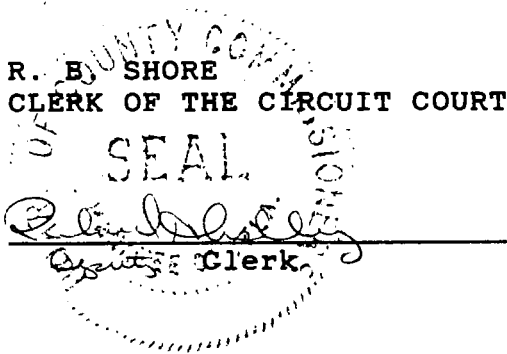
