AN ORDINANCE OF MANATEE COUNTY, FLORIDA
AMENDING MANATEE COUNTY ORDINANCE 84-04; AS
AMENDED BY ORDINANCES 84-15 AND 84-24, TO
PROHIBIT THE STOPPING, STANDING OR PARKING
OF MOTOR VEHICLES ON 3RD AVENUE EAST (PALMETTO)
A COUNTY MAINTAINED STREET LOCATED WITHIN THE
UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA;
AND PROVIDING AN EFFECTIVE DATE

WHEREAS, pursuant to Section 316, Florida Statutes, the Board of County Commissioners of Manatee County, Florida retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04 Section 1, be amended to add the following no standing or parking zone:

3rd Avenue East (Palmetto) from 19th Street East to 21st Street East

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the Office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.


