AN ORDINANCE OF MANATEE COUNTY, FLORIDA MAKING CERTAIN FINDINGS OF FACT; PROVIDING FOR THE DESIGNATION OF CERTAIN COUNTY ROADS IN THE AREA GENERALLY IDENTIFIED AS EL CONQUISTADOR COUNTRY CLUB AS GOLF CART ROADS; PROVIDING FOR THE DESIGNATION OF GOLF CART CROSSING AREAS ON CERTAIN COUNTY ROADS IN THE EL CONQUISTADOR COUNTRY CLUB AREA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.212, Florida Statutes, a golf cart may be operated only upon a County road which has been designated by a County as a golf cart road; and

WHEREAS, pursuant to Section 316, Florida Statutes, the County of Manatee, Florida, retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of Manatee County; and

WHEREAS, the Board of County Commissioners of Manatee County, Florida, has determined that the operation of a golf cart within the right-of-way of certain roads will not impede the safe and efficient flow of motor vehicular traffic; and

WHEREAS, the Board of County Commissioners of Manatee County, Florida, has determined that the speed, volume and character of motor vehicular traffic using certain roads is of such a character that golf carts may travel along or across those roads with reasonable safety; and

WHEREAS, the Board of County Commissioners of Manatee County, Florida, hasd determined that it is in the public interest to designate certain roads as golf cart roads and establish crossing areas along certain County Roads.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, that:

Section 1: The operation of a golf cart upon specified roads and streets of this County is permitted and golf carts may be operated upon those County roads within the unincorporated area of Manatee County, Florida, set forth in Appendix "A", attached hereto and made a part of this Section 1.

*Golf Cart Roads*

Section 2: The operation of a golf cart is permitted and golf cart crossing areas shall be established across those County roads and streets within the unincorporated area of Manatee County, Florida, set forth in Appendix "B", attached hereto and made a part of this Section 2.

Section 3: The Public Works Department of Manatee County shall post appropriate signs on the roads shown in Appendix "A" and Appendix "B" to warn motorists that the operation of a golf cart is allowed.

Section 4: A golf cart may only be operated as provided by Sections 1 and 2 of this Ordinance:

(a) During the hours between sunrise and sunset.

(b) If the golf cart has been equipped with efficient brakes, reliable steering apparatus, safe tires, a rearview mirror, and red reflectorized warning devices in both front and rear.

(c) The warning signs required under Section 3 of this Ordinance have been posted and remain posted. The provisions of this Section 4 may be enforced as provided in Chapter 316, Florida Statutes, and violations subject to the penalties provided therein.

Section 5: Nothing herein shall be deemed to permit the operation of golf carts in any manner not consistent with Section 316.212, Florida Statutes, and any other applicable provisions of Florida Law, including, but not limited to, rules and regulations establishing equipment that must be maintained on the golf cart or the hours during which a golf cart may be operated on roads or streets.



Those roads and streets within the El Conquistador  
Country Club identified as follows:

El Conquistador Parkway  
between 34th Street West and Courtside Drive

43rd Street West  
between Avenida Madera and El Conquistador Parkway

45th Street West  
between El Conquistador Parkway and La Jolla Drive

La Jolla Drive  
between 45th Street West and the Dead End

La Vista Lane  
between 45th Street West and the Dead End

61st Avenue Terrace West  
between 43rd Street West and the Dead End

Pinar Drive  
from 43rd Street West to 43rd Street West

DESIGNATION OF GOLF CART CROSSING AREAS

Those roads and streets within the El Conquistador Country Club identified as follows:

1. At the signalized crossing on El Conquistador Parkway between 43rd Street West and Country Club Drive.
2. Across 43rd Street West at the marked and signed locations between 61st Avenue terrace West and Pinar Drive.
3. Across 43rd Street West at the marked and signed location between Pinar Drive and Avenida Madera.
