AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-04; AS AMENDED BY ORDINANCES 84-15, 84-24, AND 88-12, TO PROHIBIT THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 11TH AVENUE WEST, AND 60TH AVENUE DRIVE EAST; COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316 of the Florida Statutes, the Board of County Commissioners of Manatee County, Florida retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County; and

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1, be amended to add the following no parking zones:

11th Avenue West (both sides)
from 35th Street West to 37th Street West
(8 AM - 4 PM School Days)


60th Avenue Drive East (both sides)
from 15th Street East to Dead End




