WHEREAS, pursuant to Section 316 of the Florida Statutes, the Board of County Commissioners of Manatee County, Florida retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County; and

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1, be amended to add the following no parking zones:

Uplands Boulevard (both sides)
from Edwards Drive to Dead End

Section 2. This Ordinance shall become effective immediately upon receipt of the official acknowledgement from the Office of the Secretary of State in Tallahassee, Florida, that this Ordinance has been filed with that office.
