AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-04, AS AMENDED BY ORDINANCES 84-15, AND 84-24 TO PROHIBIT THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 36TH AVENUE WEST A COUNTY MAINTAINED STREET LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, pursuant to Section 316 of the Florida Statutes, the Board of County Commissioners of Manatee County, Florida retains jurisdiction over the public streets, highways, roadways and parking areas located within the unincorporated areas of said County.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1, be amended to add the following no stopping, standing, or parking zone:

36th Street West from 9th Avenue West to 11th Avenue West between the hours of 8:00 AM and 4:00 PM on School Days

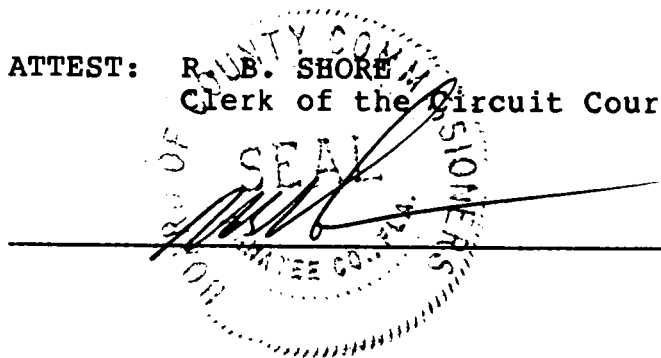


