AN ORDINANCE OF MANATEE COUNTY, FLORIDA, RESCINDING ORDINANCE 87-04 (THE OPEN CONTAINER ORDINANCE) WHICH PROHIBITED AND REGULATED THE POSSESSION OF ALCOHOLIC BEVERAGES IN MOTOR VEHICLES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on February 3, 1987, the Board of County Commissioners of Manatee County, Florida adopted Ordinance 87-04 prohibiting and regulating the possession of alcoholic beverage containers and the consumption of alcoholic beverages in or on motor vehicles; and

WHEREAS, the Legislature of the State of Florida has enacted Chapter 88-22, Laws of Florida, amending Section 316.1936, Florida Statutes to provide restrictions and regulations on the possession of alcoholic beverages in vehicles throughout the State of Florida; and

WHEREAS, Manatee County Ordinance 87-04 does not presently provide more stringent restrictions on the possession of alcoholic beverages than those restrictions provided under Chapter 88-22, Laws of Florida.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA that:

Section 1. Ordinance 87-04 is hereby rescinded.

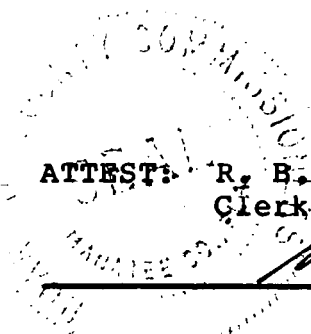
Section 2. This Ordinance shall take effect upon receipt of official acknowledgment from the Department of State that a copy of this Ordinance has been duly filed with that office.
