the Board of County Commissioners of Manatee County, Florida retains  
jurisdiction over the public streets, highways, roadways and parking  
areas located within the unincorporated areas of said County; and

NOW, THEREFORE BE IT ORDAINED by the Board of County  
Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-04, Section 1, be amended to add  
the following no parking zones:

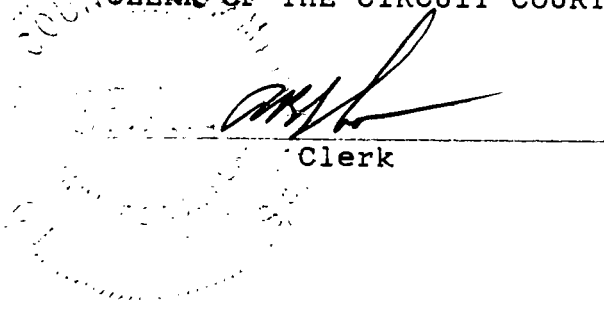
11th Avenue West on both sides between 37th Street  
West and 38th Street West between 8 AM and 4 PM  
on School Days

Section 2. This Ordinance shall become effective  
immediately upon receipt of the official acknowledgement from the  
Office of the Secretary of State in Tallahassee, Florida, that this  
Ordinance has been filed with that office.

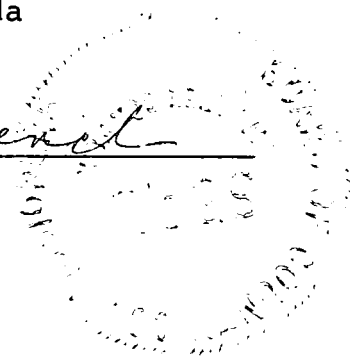
