AN ORDINANCE OF MANATEE COUNTY, FLORIDA AMENDING MANATEE COUNTY ORDINANCE 84-05; TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON 47TH STREET WEST FROM MANATEE AVENUE WEST TO RIVERVIEW BOULEVARD AND ON 53RD AVENUE WEST FROM 34TH STREET WEST TO 75TH STREET WEST AND ON 75TH STREET WEST FROM 53RD AVENUE WEST TO CORTEZ ROAD AND IN CASA LOMA MOBILE HOME PARK, AND IN SUNNY SHORES MOBILE HOME PARK, ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE BE IT ORDAINED by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zone:

- 47th Street West - 25 MPH
from Manatee Avenue West to Riverview Boulevard
- 53rd Avenue West - 50 MPH
from 34th Street West to 75th Street West
- 75th Street West - 50 MPH
from 53rd Avenue West to Cortez Road
- Casa Loma Mobile Home Park:
1st Street East - 20 MPH
from 50th Avenue Drive East to 53rd Avenue East
- Sunny Shores Mobile Home Park:
36th Avenue Drive West - 20 MPH
from 115th Street West to 118th Street West
- 40th Avenue West - 20 MPH
from 115th Street West to 118th Street West
- 116th Street West - 20 MPH
from 36th Avenue Drive West to 40th Avenue West
- 116th Street Court West - 20 MPH
from 36th Avenue Drive West to 40th Avenue West
- 117th Street West - 20 MPH
from 36th Avenue Drive West to 40th Avenue West
- 118th Street West - 20 MPH
from 36th Avenue Drive West to 40th Avenue West
