AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AMENDING CERTAIN PROVISIONS OF THE TEXT OF ORDINANCE 93-22 (THE STATE HOUSING INITIATIVE PARTNERSHIP PROGRAM [SHIP]); PROVIDING FOR THE DELETION OF CERTAIN LANGUAGE FROM SECTION V. ESTABLISHMENT OF THE LOCAL HOUSING ASSISTANCE PROGRAM; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Manatee County, Florida, adopted Ordinance 93-22, (the State Housing Initiative Partnership Program [SHIP]) effective April 29, 1993; and

WHEREAS, the April 28, 1993 letter from the Florida Housing Finance Agency contained review comments from the SHIP review committee requiring the deletion of reference to ineligible SHIP activities within the Ordinance; and

WHEREAS, pursuant to Section 125.66, Florida Statutes, on July 27, 1993 the Board of County Commissioners of the County of Manatee, Florida held a public hearing, with due public notice having been provided to consider the proposed amendment.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

SECTION 1: Section V.B.3. of Ordinance 93-22 is hereby amended to read as follows:

3. Other Affordable Housing Activities

The balance of the trust funds shall be used for the other than homeownership activities. Such activities include, but are not limited to the following:

- (1) Acquisition of improved sites;
- (2) New construction of investor owned affordable housing;
- (3) Rehabilitation of investor owned affordable housing; and
- (4) Provision of "local match" under the "State Apartment Incentive Loan (SAIL) Program or other similar federal or state program.

SECTION 2. SEVERABILITY

If any phrase or portion of this Ordinance, or the particular application thereof, shall be held invalid or unconstitutional by any court, administrative agency or other body with appropriate jurisdiction, the remaining section, subsection, sentences, clauses, or phrases and their application shall not be affected thereby.

SECTION 3. EFFECTIVE DATE

In accordance with § 420.9072(2), Florida Statutes, this Ordinance shall become effective thirty (30) days after the date of formal adoption.

The above and foregoing Ordinance was APPROVED and ADOPTED at a duly convened meeting of the Board of County Commissioners of Manatee County, Florida, this 27th day of July, 1993.
