

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 84-05, AND PROHIBITING THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON MYAKKA-WAUCHULA ROAD; IT BEING A COUNTY MAINTAINED STREET LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended in part to add the following speed limit zone:

Myakka-Wauchula Road

- From SR 70 to Boyd Road* **30 MPH**
- From Boyd Road to Ballard Road* **40 MPH**
- From Ballard Road to SR 64* **55 MPH**

Section 2. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of the State of Florida that the Ordinance has been filed with said office.

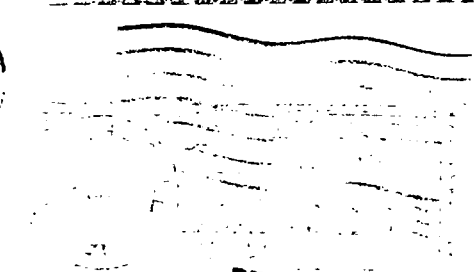
