

ORDINANCE 00-24

**AN ORDINANCE OF MANATEE COUNTY, FLORIDA,
AMENDING MANATEE COUNTY ORDINANCE 92-23 TO
INCLUDE IN THE DEFINITION OF "EMPLOYEE"
PERSONS EMPLOYED BY THE SARASOTA/MANATEE
METROPOLITAN PLANNING ORGANIZATION; AND
ESTABLISHING AN EFFECTIVE DATE.**

WHEREAS, §768.28, Florida Statutes authorizes local governmental agencies to pool liability risks and to cover tort liability for the acts of their agents; and

WHEREAS, §440.575, Florida Statutes authorizes self-insured entities to extend their workers' compensation coverage to include employees of its contractors; and

WHEREAS, the Board of County Commissioners of Manatee County finds it shares certain homogeneous risks with the Sarasota/Manatee Metropolitan Planning Organization; and

WHEREAS, the Sarasota/Manatee Metropolitan Planning Organization acts as the agent of the Board of County Commissioners of Manatee County in fulfilling the Board's transportation planning function duties, as imposed by §125.01(1)(m), Florida Statutes; and

WHEREAS, by an Interlocal Agreement dated September 26, 1994, the Board of County Commissioners of Manatee County has agreed to provide comprehensive support services to the Sarasota/Manatee Metropolitan Planning Organization.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, that:

1. The first sentence of Section 2.D. of Manatee County Ordinance 92-23 is hereby amended to add, at its end, the following words:

"... or (iv) any person who performs services for remuneration and who is actually employed full-time by the Sarasota/Manatee Metropolitan Planning Organization, while acting within the course and scope of his or her employment."

2. This Ordinance shall take effect upon its filing with the Office of the Secretary of State, in Tallahassee, Florida.

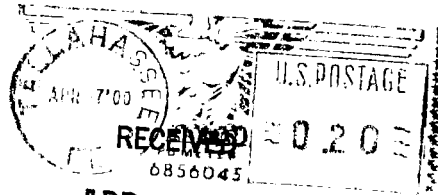

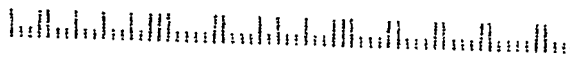
