

ORDINANCE 00-31

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 84-05; TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON 36TH AVENUE EAST, 45TH STREET EAST AND MANATEE OAKS SUBDIVISION; ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zones:

- 36th Avenue East - 25 MPH  
from 15th St. E. to the dead end.
- 45th Street East - 30 MPH  
from 44th Ave. E., north to the dead end.
- MANATEE OAKS SUBDIVISION:**
- 30th Street Court East - 25 MPH  
from 48th Ave. Dr. E. to 50th Ave. Dr. E.
- 31st Street East - 25 MPH  
from 51st Ave. E. to the cu-de-sac.
- 31st Court East - 25 MPH  
from 46th Dr. E. to 48th Ave. Dr. E.
- 32nd Street East - 25 MPH  
from 48th Ave. Dr. E. to 50th Ave. Dr. E.
- 32nd Court East - 25 MPH  
from 46th Dr. E. to 47th Ave. E.
- 33rd Court East - 25 MPH  
from 46th Terr. E. to 47th Ave. E.
- 34th Court East - 25 MPH  
from 35th Ct. E. to 47th Ave. E.
- 35th Court East - 25 MPH  
from 34th Ct. E. to the cul-de-sac.

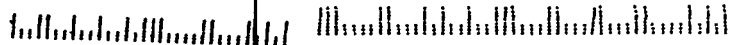
