AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 98-30; TO RESCIND PARKING RESTRICTIONS ON 18TH STREET EAST; AMENDING ORDINANCE 98-11; REGULATING THE STOPPING, STANDING OR PARKING OF MOTOR VEHICLES ON 16TH AVENUE EAST/CANAL ROAD (PALMETTO), 17TH STREET EAST/MEMPHIS ROAD (PALMETTO), 75TH STREET WEST, 82ND STREET EAST (PARRISH) AND MANGROVE POINT ROAD; ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Manatee County, as a political subdivision of the State of Florida, is empowered, pursuant to Section 316.008, Florida Statutes, to regulate the stopping, standing or parking of motor vehicles upon streets and highways within the County's jurisdiction.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 98-30, Section 1, be amended in part to delete the following right-of-way:

18th Street East From 53rd Ave. E., south approx. 350 ft.

Section 2. Ordinance 98-11, Section 1.A, be amended to add the following rights-of-way:

16th Avenue East/ Canal Road (Palmetto) From 1600 Block to 17th St. E./Memphis Rd.

17th Street East/Memphis Road (Palmetto) (south side only) From 16th Ave. E./Canal Rd. to 20th Ave. E.

75th Street West Adjacent to 115 75th St. W.

82nd Street East (Parrish) From 65 ft. west of 122nd Ave. E. , west 110 ft.

Mangrove Point Road From 5007 Mangrove Pt. Rd. to the cul-de-sac.

Section 3. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of the State of Florida that the Ordinance has been filed with said office.
