

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING ORDINANCE 84-05; TO PROHIBIT THE TRAVEL OF VEHICLES AT SPEEDS IN EXCESS OF THE ESTABLISHED LIMIT ON 1ST AVENUE DRIVE NORTHWEST, 4TH AVENUE CIRCLE NORTHWEST, 53RD AVENUE WEST, 67TH AVENUE WEST, LAKEWOOD RANCH BOULEVARD AND ON STREETS LOCATED IN BRIARWOOD SUBDIVISION, KINGSFIELD SUBDIVISION AND PERIDIA GOLF AND COUNTRY CLUB; ALL BEING COUNTY MAINTAINED STREETS LOCATED WITHIN THE UNINCORPORATED AREA OF MANATEE COUNTY, FLORIDA; REQUIRING THE ERECTION OF APPROPRIATE SIGNS; PROVIDING FOR VIOLATIONS AND PENALTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 316.189(2), Florida Statutes, the Board of County Commissioners of Manatee County, Florida, may set maximum and minimum speed limit in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE, be it Ordained by the Board of County Commissioners of Manatee County, Florida, that:

Section 1. Ordinance 84-05, Section 1, be amended to add the following speed limit zones:

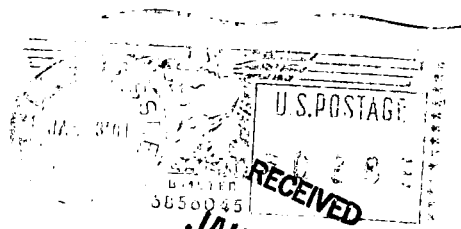
